**2007** - Beginning in 2007, Glen Simpson and his wife Mary Jacoby wrote a series of articles outlining how lobbyist working for ex-Soviets influence Washington. One article from 2007 was titled "How Lobbyist Help ex-Soviets Woo Washington. Paul Manafort is named as a key player in the story. Simpson and Jacoby were working for the Wall Street Journal at that time. Later, they would start Fusion GPS.

**October 18, 2010** - Stefan Halper and Alexander Downer speak at a seminar at Emmanuel College

**February 28, 2014** - Stefan Halper acting in concert with other conspirators invite Micahel Flynn and Russian historian Svetlana Lokhova to Cambridge in the UK to a foreign policy seminar. Halper makes sure Flynn is seated next to Lokhova. Halper then tells British intel chief Richard Breedlove that Flynn and Lokhova discussed taking a trip to Moscow and that Flynn may be compromised. This information is then relayed to American intelligence.

**Fall of 2014** - Ukrainian American DNC paid consultant Alexandra Chalupa, begins researching Paul Manafort's ties to Russia. The FBI investigates, using a wiretap, but fails to make a case.

**February 9, 2015** - US Senate forms Ukrainian caucus to further Ukraine interest. Sen. McCain is a member of the group. His right hand man David Kramer, is a member of a Ukrainian media / propaganda organization that associates with Alexandra Chalupa.

**March 4, 2015** - The NY Times breaks the story about Hillary Clinton mishandling classified information.

**March 2015** - AG Lynch tells Comey to call the HRC email investigation a "matter", Comey complies but feels queasy.

**June 16, 2015** - Donald Trump announces he will run for President. Trump focuses his speech on illegal immigration, off-shoring of American jobs, the national debt, and Islamic terrorism.

**Fall of 2015** - British GCHQ passes intel to the CIA about people around Trump having Russian ties. Specifically, Mike Flynn. The intel came from Stefan Halper. On August 27, 2018, Sara A. Carter will write a story confirming that it was Halper that invited Flynn to the London Centre at Cambridge.

**September 25, 2015** - Stefan Halper paid \$244,960.00 by an agency within the DOD.

**November 2015** - Josef Mifsud joins London International Law Centre.

**Late November 2015** - Private contractors are unlawfully allowed access to FBI/NSA database where they perform 702 queries. 85% of searches are later found to have been unlawful.

**December 10, 2015** - Michael Flynn and Jill Stein attend RT News dinner celebration and sit at the same table with Putin. Flynn is paid 45k for his speech. Putin later tells Megyn Kelly that he never had a conversation with Flynn other than a brief greeting.

**December 23, 2015** - Comey names Bill Priestap as Director of Counter Intelligence Division.

**December 28, 2015** - StrozK texts Page to ask if she got oconus lures approved. Oconus Lures means spies outside the continental US.

**January 9, 2016** - Comey promotes McCabe to Deputy Director and McCabe takes lead of Clinton probe.

**January 19, 2016** - Eric Charamella host a meeting with FBI, DOJ and State Dept officials to discuss coercing the Ukrainians to drop their investigation into Burisma and Hunter Biden and to allow the FBI to take over the investigation. Also discussed, was a plan to reopen a 2014 investigation into Paul Manafort. Two weeks later, Chahrmella hosts another meeting to put the Mainfort plan into action.

**January 2016** - Alexandra Chalupa tells senior DNC official that she feels there is a Trump / Russia connection. Chalupa obtained her information directly from the Ukranian Gvt....on Manafort, Trump and Russia. Chalupa was

paid by the DNC (a violation of campaign finance law) and therefore a suit was filed by FACT President Matthew Whitaker.

**February 8, 2016** - The US Gvt. grants a travel VISA to Oleg Deripaska so that he can enter the US. This comes five months after the FBI and DOJ meet with Deripaska to enlist his help on organized crime investigations.

**February 2016** - George Papadopolous joins London International Law Centre.

**March 6, 2016** - George Papadopolous learns he will be joining the Trump foreign policy team as an unpaid volunteer consultant. Paps is brought into the campaign under Trump campaign co-chair Sam Clovis.

**March 14, 2016** - Papadopolous first meets Misfud in Italy - one week after joining Trump team. Wikileaks recently published information that clearly show Mifsud's ties to British Intelligence and the US State Department.

**March 21, 2016** - Trump gives list of advisers to media organizations. The media passes the list up the chain to AG Lynch. Carter Page and Papadopolous are on the list. Both Paps and Page would be discussed in a national security meeting with Obama, Rice, Lynch, Rhoads, and the intel heads.

**March 24, 2016** - Papadopolous, Misfud, Olga Polonskaya, and unknown fourth party meet in a London cafe.

**Spring of 2016** - Paul Wood of the BBC reports that John Brennan began organizing the six agency task force in the early spring of 2016, no later than March 2016.

**Late March Early April** - CIA Director John Brennan begins putting together a secret six agency task force to focus on Trump Russia connections. Clapper and Strzok are a part of the task force. Agency heads from the DOJ/NSD, FBI/NSB, NSA, Treasury and the DOD are included. Cloak and dagger operations began under Brennan's secret task force that was being run out of CIA HQ in Langley, Va.

**April 2016** - CIA Director John Brennan begins telling various deep state players that Estonian Intelligence picked up intel information that Russia is pumping money into the Trump Campaign. The claim was never proven.

**April 12, 2016** - Clinton campaign lawyer Marc Elias of Perkins and Coie, hires Fusion GPS to do "opposition research".

**April 18, 2016** - NSA Director Mike Rodgers begins audit of FISA 702 inquires into US citizens.

**April 18, 2016** - Misfud introduces Papadopolous to Ivan Timofeev (an official at a state sponsored think tank called Russian International Affairs Council)

**April 19, 2016** - Mary Jacoby (wife of Glenn Simpson) visits the White House. (Jacoby was born and raised in Little Rock, Ark. and worked for a time at the Rose Law Firm with HRC).

**April 26, 2016** - In a conversation with Papadopolous, Joseph Misfud claims to have met with a high level Russian Gvt. source who claims to have dirt on HRC....according to the Mueller indictment. Mifsud denies the claim and in June of 2018 Mifsud will give an interview where he claims he was set up.

**April 30, 2016** - The DNC IT staff reports suspected hacking of the DNC network to their employees, but refuse to allow the FBI or DHS to analyze their servers.

**May 2, 2016** - Comey drafts statement exonerating HRC.

**May 3, 2016** - Trump becomes presumptive nominee of the GOP.

**May 4, 2016** - Papadopolous gives interview to London Times - not well received...rips David Cameron and says Cameron should apologize to Trump.

**May 4, 2016** - Marc Elias of Law firm Perkins & Coie brings in CrowdStrike to analyze the DNC's network.

**May 6, 2016** - New Poll shows for the first time that Trump is leading Clinton. Trump 43.4% to Clinton 43.2%. The first mentions of the Russian hacking narrative follow shortly afterward.

**May 9, 2016** - Michael Caputo is approached by an intermediary on behalf of a spy, and is offered Clinton government emails. Caputo rejects the offer.

**May 10, 2016** - Papadopolous meets with Downer...Downer initiated the meeting through his assistant Erika Thompson. Head of FBI Counter-Intelligence, Bill Priestap (Strzok's boss) also is in London on the day of the Downer meeting and is believed to have met with Downer while in London.

**May 11, 2016** - Julian Assange's lawyer Michael Rattner dies of cancer at age 72.

**May 15th 2016**, - CrowdStrike claims Russians did the hacking of the DNC network.

**May 15, 2016** - Nellie Ohr, wife of Bruce Ohr an open source researcher for the CIA, is hired by Fusion GPS. Fusion GPS is listed on the CIA's website as a contractor. More than two years later, in August of 2018, Daryl Issa would reveal on Fox news that Nellie Ohr was working for Fusion GPS in late 2015.

**Late May 2016** - Stefan Halper invites Carter Page to a July 2016 symposium regarding the 2016 election in Cambridge.

**June 9, 2016** - Meeting at Trump Tower with Manafort, Kushner, Trump Jr., Veselnitskaya, Rob Goldstone, Ike Kaveladze, Rinat Akhmetshin, Anatoli Samochornov, Aras and Emin Agalarov.

**June 10, 2016** - The DNC tells their employees that their system was hacked. The DNC blames Russia but refuses to allow FBI or DHS to examine their servers.

**June 15, 2016** - Former MI6 agent and fierce anti-Trumper Christopher Steele is hired by Fusion GPS to dig up dirt on Trump by exploring his "Russian connections".

**June 15, 2016** - Romanian hacker Guccifer, claims to have hacked the DNC.

**June 15, 2016** - FBI agent Peter Strzok changes wording of Clinton charges from grossly negligent to extremely careless.

**June 17, 2016** - WashPo publishes article titled "Inside Trump's Ties to Russia and His Universal Flattery of Vladimir Putin.

**June 20, 2016** - Steele releases first memo of what would become the dossier.

**June 27, 2016** - Lynch / Clinton tarmac meeting about golf, Brexit and grandchildren. The meeting was intended to be secret but was discovered and leaked to the press. The FBI focused on finding the source of the story but neither the FBI nor the DOJ showed any interest in exploring the subject.

**July 2, 2016** - Clinton is "interviewed" by Peter Strzok and two other agents - not under oath, not recorded, and her lawyer 'Cheryl Mills' as well as her chief of staff, who was a potential target in the investigation, were able to sit in on the interview. No grand jury. No warrants. No subpoenas.

**July 5, 2016** - FISA Court denies a request for surveillance of Trump campaign officials.

**July 5, 2016** - Steele shares "Russian Dossier" with FBI.

**July 5, 2016** - Guccifer claims to have hacked DNC again. Guccifer 2.0

**July 5, 2016** - Comey announces he will not bring charges against HRC.

**July 5, 2016** - Matthew Whitaker tells CNN that Hillary Clinton should be prosecuted and criticizes Comey for letting her off.

**July 5, 2016** - Steele meets with the FBI in Rome, Italy. Michael Gaeta, of the FBI/NSB stationed in Rome, is one of the agents Steele meets with. Steele would meet two more times with Gatea. It is alleged that the FBI picked up the tab for Steele's travel expenses.

**July 7, 2016** - Carter Page gives a speech on economic policy in Russia. Page says he was not paid for the speech.

**July 10, 2016** - Seth Rich is murdered. Still an unsolved murder. The unusual and suspicious nature of the investigation suggests foul play on behalf of the investigators. Now a cold case within the Metro PD but still an open case in the public media.

**July 11, 2016** - Stefan Halper meets Carter Page at a symposium in the UK to discuss foreign policy and the upcoming election.

**July 11, 2016** - The intermediary reaches out again to Michael Caputo to offer him Clinton Gvt. emails. Caputo left the campaign on June 20th and still wasn't interested.

**July 22, 2016** - Wikileaks releases the DNC emails showing Clinton/DNC/Media collusion to undermine Bernie Sanders campaign.

**July 24, 2016** - Wasserman-Schultz resigns as DNC head. Donna Brazile assumes the position.

**July 24, 2016** - Robby Mook (HRC campaign chair) claims Russia hacked the DNC to help Trump.

**July 25, 2016** - FBI announces it will investigate the DNC hack but does not get the DNC server. Peter Strzok leads the investigation. Eventually, the chain of custody would be lost on the server.

**July 25, 2016** - Strzok suggests to Page in a text that they need to set up a dinner with Judge Contreras. Later, Strzok would tell IG Horowitz that the dinner never happened and that it had nothing to do with any case he was working on.

**July 31, 2016** - The FBI opens a counter intelligence operation into collusion between Russia and the Trump campaign. Operation Crossfire Hurricane begins. The FBI would use the "intelligence" from the Papadopolous and Downer meeting as the reason for beginning the investigation.

**August 1st & 2nd, 2016** - McCabe, Strzok, Page, and two other agents fly to London to meet with former Australian ambassador and spy, and friend of the Clinton's, Alexander Downer at the Australian embassy. The Daily Mail suggests that Papadopoulos was discussed at the meeting.

**August 3, 2016** - CIA Director John Brennan briefs Harry Reid and others on the Gang of Eight committee, individually, on the Trump Russia collusion theory.

**August 4, 2016** - John Brennan speaks with the head of Russian intelligence about election meddling. The Russian spy chief denies the accusation. Brennan later states that Russia recruits people to further their agenda, whether that person is aware of it or not.

**August 8, 2016** - Strzok tells Page in a text message that "Trump will not be President" and "They will stop him". Later, Strzok would tell IG Horowitz that he was only trying to "reassure" Page and that stopping Trump was not meant to be taken literally.

**August 10, 2016** - Washington Post reports that Brennan may have shared Dossier with Obama.

**August 15, 2016** - Strzok texts Page about needing an insurance policy in case Trump wins.

**August 15, 2016** - Strzok and Page discuss evading rules and preserving conversations.

**August 19, 2016** - Manafort resigns....forced out of campaign due to media reports of being under investigation for lobbying activities related to Ukrainians and Russians.

**August 25, 2016** - CIA Director Brennan has secret phone call with Harry Reid about Trump Russia collusion. Reid fires off letter to FBI Director Comey two days later.

**August 1, 2016** - Stefan Halper meets with "unnamed Trump campaign official".

**September 1, 2016** - Halper meets with Sam Clovis in Washington DC to discuss foreign policy....uses association with Carter Page as an introduction.

**September 2, 2016** - Page texts Strzok to tell him that "Obama wants to know everything we're doing".

**September 3, 2016** - Stefan Halper sends an email to Papadopolous offering him \$3000. to come to London and write a paper on oil and gas issues in the Mediterranean. Paps accepts.

**September 3, 2016** - FBI seizes Weiner laptop.

**September 5, 2016** - HRC accuses Russia of interfering in the election.

**September 8, 2016** - Paul Cambetta deletes 33k emails from HRC's server while emails are under subpoena.

**September 10, 2016** - Three FBI agents visit Oleg Deripaska to enlist his help. Deripaska laughs at the idea of Trump Russia collusion and declines offer.

**September 14, 2016** - Halper meets with Papadopolous in London, and says to Paps "you know about hacking the emails from Russia don't you?"

**September 15, 2016** - Papadopolous emails Russian contact Boris Epshteyn trying to connect him with Sergai Millian.

**September 15, 2016** - FISA Court approves request for surveillance of Trump campaign members based mostly on the dossier. The FISA court used the application only. No hearings, not one question.

**September 21, 2016** - NY Times, WashPo, Yahoo News, are briefed on dossier by Steele.

**September 21, 2016** - HRC henchman Syd Blumenthal passes "Shearer Dossier" to the State Dept...first to Nuland then to Kerry. Cody Shearer is a longtime Clinton political dirty trickster and friend of Blumenthal.

**September 22, 2016** - Kerry aide and Clinton confidante Jonathan Winer passes Shearer dossier to Steele.

**September 23, 2016** - Yahoo news Michael Isakoff publishes report based on Russia dossier and possible Trump Russia collusion. Later we learn that James Baker leaked the story to Isakoff.

**September 23, 2016** - HRC releases press release touting bombshell report from Yahoo news on Trump Russia collusion.

**September 26, 2016** - DOJ/NSD admits to the FISA court that surveillance included Obama political **opponents**.

**September 27, 2016** - Stefan Halper is paid \$282,295.00 by an agency within the DOD. Likely a CIA front.

**September 27, 2016** - John P. Carlin head of the DOJ/NSD resigns after informing the FISA court of the illegal searches of the NSA database.

**September 28, 2016** - Strzok texts Page about McCabe meeting to discuss Weiner laptop.

**September 28, 2016** - McCabe hosts conference call with FBI in NY regarding the Weiner laptop and the thousands of Clinton emails on the device. McCabe would sit on the information for 21 days before the FBI in NY threatens to release the emails.

**September 30, 2017** - Matthew Whitaker tells CNN that if Trump wins, he should investigate Hillary Clinton.

**October 2016** - The FBI tells Steele that they have an informant inside the Trump campaign.

**October 7, 2016** - Wikileaks releases Podesta Emails

**October 7, 2016** - Obama Admin. officially announces Russia meddling in 2016 election.

**October 12, 2016** - It is reported that FBI agents in NY told McCabe and Strzok that they had discovered 650k emails on the Weiner laptop, including dozens of State Dept. emails. (we now know McCabe and Strzok knew about these emails in early September).

**October 13, 2016** - McCabe organizes FBI response to WSJ article that Jill McCabe got money from Clinton campaign.

**October 14, 2016** - Strzok's wife promoted to deputy director of SEC enforcement division.

**October 15, 2016** - FBI meets with Steele - offers to pay him for more Russian dossier material.

**October 19, 2016** - During debate HRC accuses Trump of being Putin's puppet.

**October 19, 2016** - Steele writes last memo for dossier and gives it to the FBI. The FBI reportedly authorizes payment to Steele.

**October 21, 2016** - DOJ/FBI files first Title 1 surveillance request on Carter Page...based on dossier.

**October 24, 2016** - NSA Director Mike Rodgers briefs FISA court on improper 702 queries.

**October 26, 2016** - NSA Director Mike Rodgers shuts down all "about" query activity.

**October 27, 2016** - During Comey staff meeting, McCabe and Strzok are asked why they are sitting on Weiner laptop emails.

**October 28, 2016** - Comey forced to reopen HRC email investigation after FBI agents in NY threaten to resign and go public if he did not.

**October 31, 2016** - FBI lead council James Baker, receives dossier info from David Corn of Mother Jones that advances the "false narrative" of Trump/Russian collusion.

**October 31, 2016** - Clinton campaign issues statement on Trump tower meeting citing Slate as their source.

**October 2016** - Christopher Steele briefs State Dept. officials in Washington on the dossier

**November 1, 2016** - McCabe recuses himself from Clinton email server investigation.

**November 5, 2016** - Ellen Rattner, brother of the late Michael Rattner, meets with Julian Assange who according to Texas business man Ed Butowski, was told by Assange that Seth Rich and his brother Aaron were Wikileaks sources for the DNC emails. This information became public in 2019 after Ed Butowski filed a federal lawsuit against 36 defendants for defamation.

**November 6, 2016** - Comey exonerates Clinton ....again.

**November 8, 2016** - Donald Trump elected President.

**November 9, 2016** - Strzok and Page have a conversation about a secret society to undermine Trump and talk about deleting their text communications.

**November 15, 2016** - Bruce Ohr meets in secret with Simpson and Steele.

**November 15, 2016** - FBI agrees to continue funding Steele dossier.

**November 17, 2016** - Mike Rogers visits Trump at Trump Tower...likely informs Trump of surveillance.

**November 18, 2016** - Trump moves campaign operations out of Trump tower.

**November 18, 2016** - Clapper and Brennan write letter to Obama asking him to remove Mike Rogers from his post.

**November 18, 2016** - McCain told of dossier at Halifax conference by Sir Andrew Wood at the request of Christopher Steele. David Kramer acts as intermediary.

**November 22, 2016** - Bruce Ohr 1st of 13 briefings with the FBI about his conversations with Steele. McCabe, Strzok, and Page were briefed by Ohr. The last briefing would be 5/17/22

**December 9, 2016** - CIA tells congress that Russia hacked the DNC to help Hillary.

**December 9, 2016** - McCain gives a copy of the dossier to Comey at FBI Headquarters.

**December 9, 2016** - Obama orders intel community to investigate Russia influence in the 2016 election.

**December 15, 2016** - Obama's intelligence officials "incidentally" spy on Trump officials meeting with the Prince of the UAE. Rice un.masks Bannon, Kushner, and Flynn.

**December 29, 2016** - Flynn speaks to Russian ambassador Kislyak...the call is wiretapped and leaked to the press.

**January 2, 2017** - Assange denies that the Clinton / DNC emails released by Wikileaks, came from Russia or any Russian or any other government source.

**January 2, 2017** - Clapper instructs Comey to inform Trump of the dossier...but only the salacious stuff. Comey never tells Trump that HRC paid for it. Comey tells Trump that CNN has the story and is just waiting for a news hook to release it. The briefing itself would become the news hook.

**January 3, 2017** - AG Lynch approves new rules for DNI Clapper to allow the DNI to expand dissemination of intelligence within the Gvt.

**January 5, 2017** - Comey secretly meets with Obama, Biden, Yates, and Rice. Comey never mentions this meeting in congressional hearings...another lie. Rice writes the "CYA" memo about the meeting.

**January 6, 2017** - Comey briefs Trump on some of the dossier but does not tell Trump the source.

**January 6, 2017** - Clapper leaks details of the Comey Trump meeting to Jake Tapper of CNN.

**January 6, 2017** - CNN's Jake Tapper reports on existence of dossier.

**January 7, 2017** - John Brennan pressures Comey to include the dossier in the final report on Russian meddling.

**January 10, 2017** - Buzzfeed releases full 35 page dossier. Buzzfeed is currently being sued by six people for defamation.

**January 11, 2017** - John Podesta meets with Glenn Simpson.

**January 11, 2017** - WSJ outs Christopher Steele as author of dossier. Steele takes his family and disappears for a while.

**January 12, 2017** - IG Horowitz announces probe into actions of McCabes role in the Clinton email investigation.

**January 17, 2019** - The NY Times reports that the White House was directly involved in the investigation of the Trump campaign.

**January 19, 2017** - Day before inauguration, DOJ/FBI gets FISA warrant renewed.

**January 20, 2017** - The BBC reports that John Brennan orchestrated the spying on the Trump campaign.

**January 24, 2017** - Michael Flynn interviewed by Strzok and two other agents.

**January 26, 2017** - Sally Yates and Bill Priestap inform White House council that Flynn was compromised by

Russian ambassador Kislyak conversation.

**January 27, 2017** - FBI interviews Papadopolous.

**January 30, 2017** - Sergai Millian named as a source of the dossier.

**January 30, 2017** - Trump fires Sally Yates for refusing to enforce travel ban.

**February 3, 2017** - Mr. Gubarev of Webzilla, files a defamation suit against BuzzFeed and Christopher Steele.

**February 8, 2017** - Sessions confirmed as AG

**February 11, 2017** - FBI interviews Joseph Mifsud while he is in DC speaking at a convention for an organization within the US State Dept. Mifsud, allegedly tells the FBI that he did not say anything to Papadopolous about Russians having Hillary's emails.

**February 13, 2017** - Trump fires Flynn for lying to Pence.

**February 14, 2017** - Strzok and Page discuss 302 on Flynn and contemplate problems if congress sees it.

**March 2, 2017** - Sessions recuses himself from Russia collusion and 2016 election investigation.

**March 3, 2017**- Nunes informs Trump that he believes Trump and his campaign were illegally surveilled.

**March 4, 2017** - Trump tweets out, "Is it legal for a sitting President to be wiretapping a race for President prior to an election?".

**March 5, 2017** - Clapper tells congress he doesn't know of any FISA warrant on Trump or associates.

**March 6, 2017** - First TowerGate video is created. I say in the video that if Trump was wiretapped it will be bigger than Watergate.

**March 18, 2017** - The WSJ writes an article suggesting that Michael Flynn failed to report to the DIA his contact with British citizen and Russian historian Svetlana Lokhova in Cambridge in 2014. Stefan Halper set up the meeting with Flynn and Lokhova as a way to frame Flynn.

**March 20, 2017** - Comey denies Trump campaign wiretapped by US Govt.

**March 20, 2017** - Comey testifies that the FBI secretly investigated Trump Russia collusion in 2016.

**March 20, 2017** - DNI Clapper denies any abuse of FISA to surveil Trump campaign.

**March 22, 2017** - Susan Rice tells PBS, she knows nothing about unmasking names of Trump officials.

**April 4, 2017** - Susan Rice admits to unmasking after previously denying it on PBS.

**April 19, 2017** - DOJ/FBI get second renewal of FISA warrant.

**April 2, 2017** - Rod Rosenstein appointed Deputy AG

**May 3, 2017** - Comey denies in congressional hearings that he nor any FBI officials leaked to the media.

**May 8, 2017** - Yates and Clapper admit to unmasking Trump and associates.

**May 9, 2017** - Rosenstein writes letter recommending Comey be fired for insubordination in relation to the Clinton email investigation.

**May 9, 2017** - Trump fires Comey

**May 9, 2017** - Andrew McCabe is interviewed by FBI INSD (inspection division).

**May 10, 2017** - Christopher Steele tells Bruce Ohr on a telephone call, that he is very concerned about Comey's firing.

**May 12, 2017** - Benjamin Wittes, confidant of James Comey, leaks conversation he had with Comey about Trump to the NY Times Mike Schmidt.

**May 15, 2017** - Rosenstein approves third extension of FISA warrant on Carter Page. No FISA court hearings, no questions from the judges. Application only.

**May 16, 2017** - Mueller interviews for FBI Director job...Trump rejects him.

**May 16, 2017** - NY Times publishes Comey memo - obtained by Comey friend and loyalist Daniel Richman of Columbia Law School. Later Comey would claim Richman is his lawyer.

**May 16, 2017** - Rod Rosenstein "reportedly" suggest to McCabe that he wear a wire to entrap Trump for the purposes of a 25th amendment coup. (This would be reported in October 2018 by the NY Times)

**May 17, 2017** - Rosenstein names Mueller as Special Council.

**May 19, 2017** - Anthony Weiner turns himself in.

**May 19, 2017** - Matthew Whitaker writes in an article that Trump did not obstruct justice by firing Comey.

**May 22, 2017** - George Neumayr of the American Spectator writes in an article that John Brennan said, that his "six agency task force" was set into motion because he felt Trump was putting the special relationship with the British at risk.

**May 23, 2017** - John Brennan testifies to the House Intelligence Committee headed by Devin Nunes. Brennan tells the committee "I was aware of intelligence and information about contacts between Russian officials and US persons that raised concerns in my mind about whether or not these individuals were cooperating with the Russians, wittingly or unwittingly, and **it served as the basis for the FBI investigation.**"

**June 8, 2017** - Comey admits to leaking memos to get a Special Council appointed.

**June 14, 2017** - WashPo reports Mueller investigating Trump for obstruction of justice.

**June 29, 2017** - Rosenstein signs final FISA warrant on Carter Page.

**July 13, 2017** - Matthew Whitaker defends Trump Jr. on CNN in regards to the Trump Tower meeting.

**July 17, 2017** - Comey admits dossier is salacious and unverified.

**July 17, 2017** - Clapper lies to congress about leaking the dossier to the media.

**July 20, 2017** - IG discovers Strzok / Page texts.

**July 26, 2017** - Stefan Halper paid \$129,280.00 by an agency within the DOD.

**July 26, 2017** - Matthew Whitaker tells CNN that the special council could be ended by defunding it.

**July 27, 2017** - IG Horowitz informs Mueller of Strzok texts. Mueller removes Strzok from the Mueller probe.

**July 28, 2017** - McCabe lies to IG Horowitz while being interviewed under oath about the WSJ article by Devlin Barrett.

**August 2, 2017** - Christopher Wray named FBI Director.

**August 4, 2017** - Matthew Whitaker describes in an article that with a little planning he could install a true believer to a political position at DOJ, as a sleeper agent, and then after Sessions is eased out, elevate him to Attorney

General.

**August 25, 2017** - Matt Whitaker writes an article where he criticizes Mueller and says Mueller used gestapo tactics to intimidate Manafort.

**August 30, 2017** - Matthew Whitaker tells CNN that Mueller's investigation is politically motivated.

**September 14, 2017** - Susan Rice admits to surveillance and unmasking on Trump campaign officials in closed congressional hearing.

**September 22, 2017** - Matthew Whitaker is installed into the DOJ as Sessions Chief of Staff by the White House.

**September 23, 2017** - Un-named Israeli national flies to Greek island of Mykonos to meet with Papadopolous. The Israeli invites Paps to Cyprus to discuss business and offers Paps \$10,000. Paps gives the money to a lawyer in Greece...then returns to the US.

**October 5, 2017** - After returning from his overseas trip, Papadopolous is arrested at Dulles International airport by the FBI. Paps admits he lied to the FBI.

**October 24, 2017** - WashPo reveals Clinton and DNC paid for the dossier after Clinton and associates denied it for over a year.

**October 30, 2017** - Manafort, Gates, and Papadopolous indicted by SC Mueller.

**November 7, 2017** - Heatstreet runs a story saying that the US used GCHQ to spy on Trump campaign.

**November 30, 2017** - Flynn signs plea agreement.

**November 2017** - Josef Misfud disappears after Papadopolous story breaks.

**December 1, 2017** - Comey's former chief of staff James Rybicki steps down.

**December 6, 2017** - Bruce Ohr demoted.

**December 7, 2017** - FBI Director Chris Wray testifies under oath that there were no 702 surveillance abuses by the Gvt. The 99 page FISA Court doc would later show that 85% of queries were illegal.

**December 7, 2017** - Former State Dept. official Johnathan Winer writes an op-ed in the Washington Post. In that op-ed, Winer writes that Steele and Syd Blumenthal were in contact with him about separate dossiers on Trump's ties to Russia. Winer says he met with Steele in September 2016 to discuss the dossier. Winer gave the "Cody Shearer" dossier to Nuland, who gave it to Kerry. Steele then passed the Shearer information, that he got from Winer, on to the FBI.

**December 11, 2017** - Nellie Ohr outed - Hired by Fusion GPS to create opposition research on Trump.

**December 19, 2017** - McCabe testifies that the dossier was critical to getting a FISA Warrant. No dossier, no wiretap.

**December 12, 2017** - 375 Page and Strzok texts released.

**December 21, 2017** - FBI Council James Baker reassigned.

**December 21, 2017** - McCabe informs congress of small group during testimony.

**December 23, 2017** - McCabe announces retirement.

**December 30, 2017** - NY Times publishes story that Papadopolous was the reason for the investigation...not the dossier.

**January 8, 2018** - Bruce Ohr demoted...again.

**January 18, 2018** - FISA abuse memo released by Devin Nunes and House Intel committee.

**January 19, 2018** - Page/Strzok texts released by IG/DOJ.

**January 25, 2018** - IG finds lost Page/Strzok texts.

**January 29, 2018** - McCabe announces resignation.

**February 4, 2018** - John Brennan tells Chuck Todd on MSNBC that the CIA and the intelligence community had collected a fair amount of information, in the summer of 2016, about what the Russians were doing, on multiple fronts and that he wanted to make sure that the FBI had full access to the information.

**February 7, 2018** - DOJ/NSD official David Laufman resigns.

**February 9, 2018** - DOJ official Rachel Brand resigned...responsible for FISA request.

**February 16, 2018** - Mueller indicts 13 Russian trolls and 3 Russian companies, one of the companies did not exist at the time the crimes are alleged and the 13 trolls appear to be non affiliated users. Mueller has requested that the speedy trial rule be revoked. Currently waiting for the judges ruling.

**March 5, 2018** - NSA Director Mike Rodgers sends a classified letter to Nunes disputing Brennan's claims that dossier was not used in the ICA and was not central to the investigation.

**March 16, 2018** - McCabe fired

**March 29, 2018** - Sessions reveals existence of Prosecutor John Huber...appointed August 2017.

**April 30, 2018** - Gateway Pundit reports that James Comey had a conversation with Bob Mueller only hours after being fired on may 9, 2017. The conversation is alleged to have taken place as Comey was returning from California.

**May 5, 2018** - James Baker and Lisa Page resign.

**May 16, 2018** - NY Times leaks operation Crossfire Hurricane. The story reveals that the FBI opened the counter-intelligence operation on July 31, 2016 based primarily on the conversation between Papadopolous and Alexander Downer.

**May 17, 2018** - The American Spectator publishes a story where they name John Brennan and the six agency task force for the investigation into the server at Trump Tower, where they used national security letters to launch surveillance. The story also claims that both Alexander Downer and Stefan Halper were working with the six agency task force.

**May 19, 2018** - Stefan Halper unofficially outed as FBI/CIA/MI6 informant/spy by internet sleuths.

**May 20, 2018** - Daily Caller post article describing how Ed Cox brought Carter Page into Trump campaign. Cox says Page asked to be involved and Cox said since Page had worked on John McCain's 2008 campaign thought it would be good to have him as a consultant to the campaign on energy related matters.

**May 26, 2018** - Clapper tells CNN that Obama likely didn't know about an "informant" and that he did not know about the informant.

**May 30, 2018** - Lee Smith writes bombshell article that reveals Josef Mifsud is alive and well and talking. Mifsud is a key figure in a book that is being written by Mifsud friend and former business partner Stephen Roh and French political analyst Therry Pastor. Smith interviews Roh and Pastor and learns that Mifsud is in hiding in Italy and was told to hide by Italian official Vincenzo Scotti the day after Papadopolous was outed. According Roh and Pastor, Mifsud never told Paps anything about Clinton emails and that he (Mifsud) feels he was used to set up Papadopolous.

**First Week of June** - Michael Caputo and Roger Stone go to congress to update their testimonies to include their

contact with Mr. Hank Greenberg, who offered both dirt on HRC for two million dollars. Both refused the offer. Mr. Greenberg is a Russian who claims with validating evidence that he has been an informant for the FBI.

**June 1, 2018** - FBI Interviews Comey in regards to the McCabe investigation, set in motion by the IG criminal referral.

**June 2, 2018** - McCabe seeks immunity deal from Senate Intel committee.

**June 4, 2018** - Sally Yates tells Morning Joe that "we were investigating the Trump campaign"...in contradiction to James Clapper who says that they were not investigating the Trump campaign.

**June 4, 2018** - RealClearInvestigations reports that the recently confirmed CIA Director Gina Haspell, was the station chief of the CIA in London from 2014 to 2017.

**June 5, 2018** - US Senate re-releases previously redacted pages of Strzok/Page texts that reveal more hard evidence that Strzok was seeking approval to use multiple spies against the Trump campaign.

**June 5, 2018** - FBI indicts and arrest Senate intel panel security director James A. Wolfe for leaking classified and top secret information.

**June 14, 2018** - IG Report on FBI Handling of HRC email investigation is released. No Bombshells yet...but a thousand knife cuts. Most damaging so far is a text where Strzok tells Page that he or "they" would stop Trump from becoming President. Was redacted and kept from congress in an earlier release.

**June 18, 2018** - Christopher Steele gives deposition in the BuzzFeed case. Mr. Gubarev's attorney's say they are pleased with the testimony.

**June 20, 2018** - Mark Meadows outs FBI agents #1 and #5 that were blocked in the IG report because the FBI told the IG that the two worked in counter intelligence. Turns out that was a lie. The two agents are Sally Moyer and Kevin Kleinsmith. Kleinsmith has ties to democrats and the two were also having an affair.

**June 21, 2018** - Judicial Watch obtains docs from FOIA request, showing Henry Kerner (former chief of staff to John McCain) was the person that suggested to Lois Learner that she audit tea party groups.

**June 21, 2018** - Former Obama Admin. cyber security coordinator Michael Daniel confirms previous report that Susan Rice gave him a stand down order on investigating the Russian meddling in the 2016 election.

**June 22, 2018** - Henry Kerner denies he was the one who recommended to Lois Learner that he should audit tea party groups. Kerner currently is the chief council of the special councils office.

**June 23, 2018** - Henry Greenberg, who pitched Michael Caputo and Roger Stone on getting dirt on HRC is outed as Russian national with deep ties to US Gvt. as an informant. Greenberg's real name is Gennady Vasilievich Vostretsov. Vostretsov testifies under oath that he has been an informant for the US Gvt. for 17 years. Vostretsov has served 12 years in prison for violent crimes, has received 14 special visas for US Gvt informants, has 8 arrests and has multiple aliases.

**June 25, 2018** - IG report reveals that Bill Clinton and Loretta Lynch have different accounts of the details of the tarmac meeting. Horowitz personally interviewed both. Congress and Judicial Watch continue to request documents regarding the tarmac meeting.

**June 26, 2018** - Republicans in the House vote to a point of order to force Rosenstein to respond to all subpoenas for documents in seven days or face impeachment. Rosenstein indicates that he will not comply and will allow the matter to go to court.

**June 29, 2018** - Last Refuge reports that there is a missing appendix in the IG report. The appendix is believed to show evidence that Loretta Lynch was funneling intelligence information on the Clinton server investigation to Clinton aide Maria Renteria. Speculation is that this is what Comey was referring to when he talked about a piece of information that forced him to take the reigns of the Clinton investigation.

**June 28, 2018** - Rosenstein testifies to congress that the FISA he was briefed on by DOJ lawyers and signed off on

did not match with the FISA application that was presented to congress.

**June 29, 2018**, Special Council Bob Mueller files a motion in the Michael Flynn case to delay the sentencing for a third time. Speculation is that it has to do with the IG investigation of the Flynn 302's that were possibly altered.

**June 29, 2018** - McClatchy does a story where they name the FBI National Security Branch as the FBI group that was part of the six agency task force. Carl Ghattas was named by Comey as the Executive Director of the FBI NSB in February 2017. FBI counter intelligence falls under the FBI NSB and the FBI NSB answers to the Attorney General.

**June 30, 2018** - It is revealed that Stefan Halper has dual British and American citizenship.

**July 2, 2018** - Paul Sperry reports that the FBI in NY contacted FBI HQ in D.C. on 9/28/2016 to advise them on Clinton emails that were on the Weiner laptop and that the FBI HQ in D.C. need to follow up with subpoena to look at those emails. FBI HQ in D.C. told the IG that they advised the FBI in NY to follow up on the search. Clearly, somebody is lying.

**July 2, 2018** - Paul Sperry identifies Sally Moyer as the FBI attorney in the General Council's office who balked at obtaining the search warrant for the Weiner laptop. Moyer knew of the laptop and it's contents on 9/29/2016.

**July 3, 2018** - Senate Intelligence Committee releases their report on the Russian interference in the 2016 election. Deep State gatekeepers Warner and Burr's statement was that the committee found that Russia did interfere on the side of Trump and it did have an impact on the election. They further stated that the Russians hacked the DNC and Podesta and acted with Wikileaks. They based their findings mostly on the intelligence report from Clapper, Brennan and Comey. The Senate finding is nearly the opposite of the House Intelligence finding on the matter, despite the fact that they had the same documents, witnesses and intelligence briefings.

**July 3, 2018** - Imran Awan cops plea deal and will likely walk with just probation. Awan plead guilty to one charge of bank fraud. Awan's wife and brother face no charges. No other charges are expected in the case and it is presumed it will be a closed case.

**July 3, 2018** - Chairman Goodlatte issues a subpoena to Peter Strzok to appear on July 10, at 10:00 am for a public hearing. Strzok's attorney is suggesting they will not answer the subpoena, stating that it is an obvious set up.

**July 4, 2018** - Paul Sperry identifies Trish Anderson and Sally Moyer as the attorney's that provided Comey with the legal backing to define down Hillary's crime from grossly negligent to extremely careless.

**July 7, 2018** - John Solomon writes blockbuster story on SpyGate. Solomon reveals from Strzok / Page texts, that the "team" was planting articles or sourcing articles, then using them to launch investigations..including surveillance. Solomon reveals that John Carlin was the top official that gave final approval for the warrant, and then resigned days later. Solomon reveals that there were four investigations going on around Trump associates during 2016. Also, the FBI planted a technical surveillance expert into Trump's transition team. Strzok texts also prove that there were multiple agencies running informants "spies" and "agent provocateurs" into the Trump campaign.

**July 10, 2018** - Paul Sperry reports that Peter Strzok created a fake timeline of the Weiner laptop email recovery to leave a misleading record for the file, after the fact, for the purpose of CYA and getting everyone in Comey's small group on the same page. This activity took place on or about the 3rd of November 2016.

**July 12, 2018** - Peter Strzok appears in open hearings with the joint oversight and reform committees. Strzok defends his texts and says they did not influence his actions. Strzok is smug, arrogant and refuses to answer many questions because of ongoing investigations.

**July 13 and 16, 2018** - Lisa Page appears in front of joint committee behind closed doors. Members in the hearings describe Page as cooperative and direct. Leaks from the meeting suggest that Page told the committee that the texts mean exactly what they said...countering Strzok's explanation of the texts between he and Page.

**July 16, 2018** - In a press conference with Trump and Putin in Helsinki, Putin states that Bill Browder funneled 400k dollars through the Clinton campaign (Foundation). Putin agrees to let Mueller interview the 12 spies he indicted in exchange for information about the Browder activities with the Clinton foundation.

**July 17, 2018** - The Daily Caller publishes a story saying that China hacked Clinton's private server and gained access to at least 30k emails. The DC further claims that the top tier of the FBI knew about it and covered it up. Named is Comey, Strzok, Priestap, and McCabe.

**July 17, 2018** - News reports from Russia report that Russia has arrested a Russian national named Sergai Mikhailov for spying for the CIA. Mikhailov is alleged to have given information to the CIA that Putin and the Russian intelligence services were involved in meddling in the 2016 election to include hacking and phishing scams.

**July 19,2018** - James Clapper unwittingly tells CNN that Obama set off the sequence of events that lead to the Mueller investigation by tasking the intelligence community assignment.

**July 20, 2018** - Carl Ghattas, head of the FBI NSB (National Security branch) calls it quits. Ghattas was most certainly a member of the six agency task force. Ghattas was best friends with McCabe...they were roommates at Duke University.

**July 21, 2018** - DOJ releases 412 page FISA application used against Carter Page. The release came late on Saturday evening. The FISA clearly shows that the dossier and the credibility of Christopher Steele was used as the reason to get the FISA's. The FISA application never mentions that HRC paid for the dossier or that Steele was fired by the FBI for violating their policy for informants. The FISA app accuses Page of plotting with Manafort and meeting two Russian nationals with Kremlin connections. Neither of these claims were ever proven to be true.

**July 27, 2018** - The Federal District Court Judge in the Gubarev vs BuzzFeed civil case in Florida rules that Glenn Simpson and others of Fusion GPS must appear and answer an array of questions on the creation, investigation, and dissemination of the dossier. Fusion GPS lawyers had battled for a year citing 1st amendment and client privilege. The Judge has ruled against and so, the case will convene in November and Simpson will be forced to testify.

**July 27, 2018** - Judge in Buzzfeed case rules that the DNC must provide all evidence that supports their accusations against Mr. Gubarev...that his company, Webzilla, hacked the DNC. All forensic data as well as data from the server that was produced by CrowdStrike. Also, DNC officials must take the witness stand to testify and must sit for depositions for Mr. Gubarev's attorneys.

**July 28, 2018** - Conservative Treehouse and Markets Work team up to produce a story that details the charges against James E. Wolfe. Mr. Wolfe was indicted by the DOJ for lying to the FBI. However, it appears that Mr. Wolfe was the person that leaked the Carter Page FISA warrant docs to his girlfriend Ali Watkins. Questions are now being ask as to why no charges have been brought for leaking classified information. Suspicions are that Mr. Wolfe may have been directed to leak docs by some member(s) of the Senate intel committee. Situation is fluid at this time.

**August 3, 2018** - George Neumayer writes in the American Spectator, that it was Alexander Downer who Peter Strzok met with when he went to London the day after opening the Counter-intel operation Crossfire Hurricane. Neumayer opines that the purpose of the Downer Strzok meeting was to discuss setting the trap for Papadopolous.

**August 3, 2018** - The FBI releases heavily redacted documents that show the the FBI paid Christopher Steele and met with him at least twelve times after the Nov. 8, 2016 election.

**August 3, 2018** - Newly released FBI documents show that the FBI continued to use Christopher Steele as a source, even after they terminated their agreement with him as a confidential source. Steele began meeting with Bruce Ohr and Bruce Ohr passed the information from Steele to the FBI.

**August 4, 2018** - Sundance from Conservative Treehouse discovers from newly released documents that Peter Strzok did not look at the 694K Clinton emails and Blackberry communications on the Weiner laptop until the day after the Nov. 8. 2016 elections.

**August 7, 2018** - Chuck Ross of the Daily Caller reports that Val Gurvits, attorney for Mr. Gubarev, will share Christopher Steele's deposition with congressional committees investigating "SpyGate".

**August 8, 2018** - True Pundit reports that Sally Yates and Bruce Ohr worked with Christopher Steele before during

and after the 2016 election, even after the FBI was supposed to have terminated their relationship with Steele as a confidential informant.

**August 8, 2018** - Newly released FBI documents reveal that Senator McCain illegally fed classified FBI intelligence to Fusion GPS and Christopher Steele to set up Trump Tower meeting...and the top FBI brass helped plot the scheme.

**August 10, 2018** - Judicial Watch publishes 5 newly discovered Hillary Clinton classified emails that were on her un-secure home server.

**August 11, 2018** -New Steele / Ohr texts reveal that Steele was lobbying Ohr on behalf of Oleg Deripaska and suggesting that Deripaska could be helpful to the investigation. Steele asked Ohr to keep an eye on the discussions about whether or not to grant Deripaska entry into the US.

**August 11, 2018** - New Steele / Ohr text reveal that Adam Waldman was representing Deripaska, Steele and Julian Assange. Waldman refers to someone as "Our Guy". Most speculate that Our Guy is Deripaska, Assange, or someone working for the DOJ.

**August 14, 2018** - Papadopolous files for discovery despite having plead guilty to lying to the FBI. Paps wife appears on Fox News to say that her husband should withdraw his guilty plea.

**August 15, 2018** - A wide range of media outlets report that Pentagon employee Adam Lovinger, filed a complaint in the fall of 2016 against Stefan Halper, who was working for the office of net assessment. Lovinger's complaint was that Halper was being given sweetheart deals. James Baker was the senior over that department. The Obama administration punished Lovinger by revoking his security clearance.

**August 15, 2018** - Sarah Carter acquires a text from Steele to Ohr where Steele tells Ohr that he is concerned about what congress has been briefed on... regarding "us, our assets, and previous work".

**August 16, 2018** - Trump strips John Brennan's security clearance for erratic behavior.

**August 17, 2018** - Independent journalist Matt Couch claims that the DC Metro police have evidence that Donna Brazile was at the hospital where Seth Rich was taken on the morning of his murder. Brazile is alleged to have been caught on security cameras entering the hospital at around 4:00 a.m., just minutes before Rich was shot. Brazile denies the claim.

**August 17, 2018** - DOJ attorney George Toscas is deposed by the House Joint Committee. Toscas was deeply involved in the Weiner laptop scandal, the HRC investigation, and the FISA warrants on Carter Page.

**August 17, 2018** - Mueller presents the court a sentencing memo recommending 30 days in jail for Papadopolous for lying to the FBI and "hindering the investigation".

**August 18, 2018** - 63 pages of Bruce Ohr and Chris Steele have been released to date. More evidence mounts that Steele was working for the FBI through Ohr after Steele was released as a confidential informant, for leaking to the media. More texts that show Mueller was cooperating with and likely receiving information from Steele.

**August 20, 2018** - George Papadopolous tweets out "Tick Tock" just a half hour after his wife posts an image of herself wearing a MAGA hat. Paps wife says her husband was set up.

**August 20, 2018** - Byron York writes an article in the Washington Examiner that shows Muller identified Papadopolous as only a bit player in the Trump Russia affair.

**August 21, 2018** - In an interview with Fox, Trump says that it was Rosenstein that recommended Chris Wray to be FBI Director.

**August 22, 2018** - Paul Sperry reports that Peter Strzok hand picked the HRC emails on the Weiner laptop that were to be looked at and there were only a little over 3000 emails that were reviewed out of 894k emails that were discovered. This means that Comey has been caught in another lie.

**August 22, 2018** - Julian Assange's mother...Christine Assange, sends out cryptic tweet saying that "A DNC Bernie

supporter disgruntled with rigging leaked docs proving corruption" The tweet was quickly removed after it was posted.

**August 23, 2018** - Gateway Pundit reports that Charles Tawil was the man that gave Papadopolous the \$10k payment in Greece. Tawil worked for Robert Muller in 2006 when Muller was the FBI Director. Tawil, also believed to be an intelligence operative for Israel and the US.

**August 24, 2018** - Big League Politics reports that Russian lawyer and contractor for Fusion GPS, Maria Veselnitskya, was working out of the offices of law firm Cozen O'Conner (a law firm run by an anti Trump former Obama official whose super PAC donated to HRC and Jeb Bush in 2016).

**August 25, 2018** - Clinton confidant and lawyer for Michael Cohen, Lanny Davis, admits that he was the source for the story that said Michael Cohen was in a meeting where Trump and Trump Jr. discussed the trump Tower meeting...essentially admits he lied.

**August 25, 2018** - ABC reporting that Bruce Ohr acted alone and that none of his superiors knew about his meetings with Steele, Simpson and FBI Counter-intelligence officials.

**August 25, 2018**- Lawyer for Steele, Deripaska, and Assange, and intermediary for the Senate Intel committee, Adam Waldman, photographed having dinner in NY after his lawyer stated in a letter to Chuck Grassley that his client was in Europe on an extended business trip.

**August 25, 2018** - Chuck Ross of the Daily Caller writes a story suggesting that Sergai Millian offered Papadopolous 3K a month to spy on the Trump campaign. Paps is alleged to have declined.

**August 26, 2018** - Coup plotter Senator McCain dead at 81.

**August 26, 2018** - China hacked Hillary's private server and collected Hillary's emails in real time. Louie Ghomert continues to apply pressure on the issue. Not sure how many emails China has. Strzok was notified of the hack by the ICIG but did nothing.

**August 26, 2018** - The Business Insider publishes an article claiming that China hacked Hillary Clinton's private server and that the information collected resulted in 18 to 20 CIA assets being imprisoned or killed. The FBI had been notified of the hack but refused to take any action.

**August 27, 2018** - FBI agent Jonathan Moffa, who was present at the interview of Michael Flynn, conducted by Peter Strzok, says that the FBI does leak stories to the press and then uses those stories as evidence to secure warrants and justify investigations. This would include FISA warrants and national Security letters.

**August 27, 2018** - Sara A. Carter reports that Pentagon Whistleblower Adam Lovinger, was demoted, stripped of his security clearance and later fired for blowing the whistle on Stefan Halper. Lovinger discovered Halper had been paid over a million dollars for writing reports while at the same time, accepting money from Russian oligarchs and former Russian Gvt. officials.

**August 27, 2018** - The Hill reports that Christopher Steele's firm, Orbis Business Intelligence, was hired by Oleg Deripaska in 2012 to do investigative work as part of a lawsuit that Deripaska was involved in.

**August 27, 2018** - The Hill article also claims that it was Steele that set up the meeting between Bruce Ohr, Deripaska, and FBI investigators. The meeting is believed to have been an effort to get Deripaska to help the FBI with investigations into organized crime. The meeting took place on September 2015.

**August 28, 2018** - Former CIA head John Brennan goes on MSNBC and says that the activities that Bruce Ohr was involved in were known to the DOJ and that the DOJ and FBI were coordinating closely together.

**August 28, 2018** - John Brennan tells Rachel Maddow that the "Fusion Center" (secret task force) was located within the CIA and brought together the NSA, CIA and FBI in order to make sure the dots were connected.

**August 28, 2018** - Fox news reports that members of congress that questioned Bruce Ohr say that Ohr told them he has never been interviewed by Mueller or John Huber.

**August 28, 2018** - Paul Sperry writes an article that reveals the name of the FBI case agent that discovered the Clinton emails on the Weiner laptop. The FBI agents name is John Robertson.

**August 28, 2018** - Daryl Issa tells Fox that after interviewing Bruce Ohr that they now know that the FBI and DOJ continued using the dossier to justify their investigation after the election...even though they knew the dossier was not credible.

**August 28, 2018** - Daryl Issa tells Fox that Nellie Ohr began working for Fusion GPS in November 2015...not April 2016, as previously believed.

**August 28, 2018** - John Brennan tells Rachel Maddow on MSNBC that "Anytime that we would incidentally collect information on a US person, we would hand that over to the FBI because they had the legal authority to do it"

**August 28, 2018** - Bruce Ohr contradicts ABC by saying in his deposition that other people in the FBI and DOJ were aware of his meetings with Steele and Glen Simpson and they knew his wife Nellie was working for Fusion GPS.

**August 28, 2018** - Mark Meadows tells Fox that Bruce Ohr said in his deposition that "they" knew the dossier had credibility issues but used it anyway to secure warrants and justify investigations.

**August 28, 2018** - John Ratcliffe tell Fox that none of the four FISA warrants signed off on by Yates, Comey, McCabe and Rosenstein mentioned Bruce or Nellie Ohr or said anything about their involvement in the cultivation of the material in the dossier or their contacts with Glenn Simpson and Christopher Steele.

**August 29, 2018** - Victoria Toensing tells FOX that John Huber has not interviewed her client, William Campbell, FBI informant, regarding the Uranium One case.

**September 1, 2018** - More evidence that the Trump Tower meeting was a setup. Edward Lieberman, friend of the Clinton's met and communicated with Glenn Simpson, and meeting attendees Veselnitskya, Ahkmetshin, and Samochornv, including having dinner on the night of the Tower meeting.

**September 1, 2018** - The NY Times publishes a story saying that the Obama Admin. was trying to flip Oleg Deripaska

**September 1, 2018** - Newly released documents show that Papadopolous told investigators that he never told anyone in the Trump campaign about Russians having Clinton's emails.

**September 1, 2018** - In the newly released documents, Papadopolous now states that Sessions "liked the idea of meeting with Putin" and said the campaign should "look into it". This contradicts two other meeting attendees accounts of Sessions response.

**September 1, 2018** - Jeff Carlson of the Epoch Times writes article explaining the relationship between FBI agent Michael Gaetta and Christopher Steele. Carlson points out that Loretta Lynch was Gaeta's boss when she was US attorney for Eastern District of NY. The relationship was in association with the FIFA Soccer Investigation. The judge who oversaw the case was Raymond Dearie. Dearie was the FISA court judge that signed off on the 3rd renewal of the FISA warrant on Carter Page.

**September 1, 2018** - Bruce Ohr admits in deposition to the House Joint Committee, that he was keeping Andrew Weissmann up to speed on the information he was getting from Christopher Steele. Weissmann is Muller's lead attack dog on Muller's team.

**September 1, 2018** - Bruce Ohr tells the House Joint Committee that he briefed about six FBI officials on his meetings with Christopher Steele, including McCabe, Strzok and Page.

**September 1, 2018** - Judicial Watch learns in a legal hearing that there were NO hearings in the FISA Court on the Carter Page FISA warrant and the three renewals. The Court ask no questions. The FISA 's were granted on the basis of the Applications only.

**September 1, 2018** - Trump tweets that the FISA court judges need to call in Comey, Yates, McCabe and Rosenstein and ask them about lying to the FISA court. Trump continues to tweet about Hillary's emails and is

suggesting that Sessions may not be around much longer and that he may get involved in the investigation into Spycgate.

**September 2, 2018** - Jeff Carlson of Epoch Times confirms that Nellie Ohr did start working for Fusion GPS in late fall of 2018.

**September 2, 2018** - Internet sleuth REX reveals that the AG can issue a FISA based on an emergency, and may bypass the FISC. Loretta Lynch was Obama's AG. The day after the DOJ began preparing the FISA application on Carter Page, Obama made the public statement about Russia meddling in the 2016 elections.

**September 2, 2018** - Greg Jarrett states on FOX that Trump may declassify the documents on the Russia investigation....i.e. the Mueller investigation.

**September 3, 2018** - AP reports that a grand jury has been seated in regards to Andy McCabe...likely was appointed about two months ago and witnesses have been brought in to testify...no names of who the persons are that have testified.

**September 5, 2018** - Gateway Pundit and others reporting that the FBI/DOJ bypassed FISA Court to get warrants on Carter Page. It appears that AG Lynch used a little known trick to get around the FISA court. If this is true, it would have required the President's authorization.

**September 6, 2018** - John Slomon of The Hill writes article that claims Bruce Ohr met with the FBI as early as July 2016 on the advice of Christopher Steele. Solomon says that there were multiple contacts between Ohr and Steele in Jul 2016. Also, that Ohr met with Peter Strzok one day before Strzok launched Operation Crossfire Hurricane on July 31, 2016.

**September 7, 2018** - Papadopolous sentenced to 14 days in jail and a \$9,500.00 fine, for lying to the FBI.

**September 7, 2018** - ABC releases a two year old interview between Brian Ross and Sergai Millian. Millian offers nothing that would implicate Trump or himself in the collusion narrative.

**September 8, 2018** - Papadopolous does interview with CNN Jake Tapper. Paps says that Sessions supported idea of Trump Putin meeting during campaign. Paps also talks about Halper, Paps description of the first meeting with Halper provides more evidence that Halper was trying to set up Paps by asserting that Paps knew about Russian hacking...which Paps denied to Halper was true.

**September 8, 2018** - DNC states in a court filing that they have tried to serve Joseph Mifsud but have not been able to locate him and tells court that they believe he is deceased.

**September 9, 2018** - Mark Meadows sends letter to Deputy AG Rosenstein insisting he investigate the latest Strzok Page texts. The texts are a discussion about a "media leak strategy". Strzok congratulates Page on a good job in the discussion. These texts happen at the same time that the Washington Post writes two articles on Carter Page being investigated for Russia ties.

**September 10, 2018** - Stephen Roh tells the Daily Caller that Mifsud is alive and well. Mifsud has been given a new identity and is living in a very nice place. Also that Mifsud is fully cooperating with identifiable intelligence agencies and that he is not a Russian spy. Roh suggest that Mifsud was working for MI6 but also has ties to other western intelligence agencies.

**September 10, 2018** - Papadopolous's wife post a pic on Twitter of Alexander Downer and Stefan Halper together at an event in 2010.

**September 10, 2018** - Papadopolous post three tweets suggesting that Alexander Downer recorded their conversation and should be exposed and investigated. Paps also suggested British Intelligence was weaponized against an American citizen and that he believed Downer was working for someone.

**September 10, 2018** - Gateway Pundit writes that Alexandria Chalupa admitted that she told the Clinton Campaign about Paul Manafort working for Yanokovich. That would have been early March 2016. Glenn Simpson also told the Senate Intelligence Committee that he began working with Christopher Steele when Manafort came in to the campaign. Steele, says he wasn't hired by Fusion GPS until June.

**September 10, 2018** - Papadopolous tells ABC News that he did not take Mifsud's comment about Russia having Clinton's emails seriously, because Mifsud could not deliver on contacts in the Russian Gvt. to set up a meeting with Trump and Putin...meaning, he's not that connected.

**September 10, 2018** - Papadopolous says that Sessions was enthusiastic about setting up a meeting with Russia and specifically Putin himself. Sessions testified under oath to the opposite and stands by his testimony.

**September 10, 2018** - Papadopolous tells ABC News that he doesn't recall telling Alexander Downer about the Russians having Hillary's emails. Paps says he remembers the event very well but has a different recollection than Downer on the conversation.

**September 10, 2018** - Bob Goodlatte tells Maria Bartiromo that he will subpoena Lynch, Yates, Nellie Ohr, Glenn Simpson and others during the coming weeks.

**September 11, 2018** - Joe DiGenova tells WMAL Radio, that former FBI General Council, James Baker, is cooperating in an investigation into James Comey.

**September 13, 2018** - US Intelligence Sources tell Gateway Pundit, that Christopher Steele was actively working for MI6 during the time he was working on the Clinton / Fusion GPS dossier. Steel was believed to have left MI6 in 2008. Sources also say that Steele was meeting with Russian SRV (Foreign Intelligence Service) and the FSB (Federal Security Services). If the FBI knew about this relationship then the FBI violated US Espionage laws.

**September 13, 2018** - More Strzok / Page texts. The latest texts show more evidence of Strzok and Page discussing the writing of "op-eds" that had been approved (likely by McCabe) and Page talks about making them more "folksy" and not so much like a news article. The new texts are from September 2, 2016.

**September 13, 2018** - Former NSA Director Mike Rogers tells reporters during a speech that Trump never ask him to push back against the "collusion investigation" and said he was never directed or coerced to do anything. This contradicts Comey's allegations and a leaked report from May of 2017.

**September 14, 2018** - Newest Strzok Page texts reveal discussion about the NY Times being upset that the WashPo got a scoop...leaked from FBI DOJ. Strzok telling Page that McCabe and Kortan need to smooth it over with the NY Times.

**September 14, 2018** - More Strzok Page texts have Strzok telling Page that "our sisters" are also leaking and it is politically motivated...it is suspected that Strzok is talking about the intel community.

**September 16, 2018** - Joe Di Genova tells Fox News that former FBI Special Council James Baker has been cooperating with the Government. Di Genova refers to a grand jury that is looking into Comey, McCabe, Yates, Strzok and Page, and that the investigation is likely coming from the DOJ National Security Division.

**September 16, 2018** - The newest Strzok / Page texts has Strzok telling Page "It will make your head spin to realize how many stories we played a major role in!" then "sheesh, this has been quite a year" then Strzok sends Page a link to a NY Times article entitled "NY Times Most Read Stories of 2016".

**September 16, 2018** - In a text of January 10, 2017, Strzok tells Page that he and Bill (assume Priestap) were watching CNN a ton, and that now that the story is out, we can use it to interview some people. Three weeks later the FBI questioned Papadopolous.

**September 17, 2018** - Multiple news organizations reporting that Lisa Page told House investigators that at the time of the beginning of the Mueller probe, May of 2017, that the FBI did not have evidence of Trump Russia collusion.

**September 18, 2018** - President Trump orders declassification and immediate release of 20 pages of the Carter Page FISA application that was not previously released. Also the 12 Bruce Ohr 302s, as well as all texts from Comey, McCabe, Strzok, and Page in unredacted form....and all notes from the FBI Russia investigation, also in unredacted form.

**September 18, 2018** - Mueller announces sentencing date for Michael Flynn to be December 18 2018.

**September 18, 2018** - True Pundit reports that McCabe and Strzok were caught in a sting operation headed up by FBI Director Wray. The sting was run out of the office of the Inspector General. The sting involved catching McCabe and Strzok trying to destroy evidence during the last few days that they had access to FBI files and computers. Both are believed to be the targets of a grand jury investigation. The grand jury is believed to have been put in place by John Huber.

**September 19, 2018** - George Papadopolous publicly calls for an investigation into western intelligence officials and operatives that initiated contact with him during the 2016 campaign. Paps names Halper, Downer, Erika Thompson (Australian intelligence) and Azra Turk (Israeli Intelligence). Paps also claims that Obama, Clapper, Brennan and the British Gvt. knew about the contacts with him by these suspicious individuals connected to western intelligence.

**September 19, 2018** - Pelosi, Schumer, Warner, and Schiff, the gang of four, send a letter to Wray, Rosenstein and Coates advising them not to declassify the documents ordered to be declassified by President Trump and to block their release. The letter also demands that the gang of four be briefed before any release. The letter also refers to previous agreements between them not to provide information to Trump or his lawyers.

**September 20, 2018** - Alexander Downer is asked in a BBC interview about spying on Papadopolous in 2016. Downer dances around the question but does not deny it.

**September 21, 2018** - After not cooperating with the House Joint Select Committee, Chairman Goodlatte says he will subpoena Nellie Ohr and James Baker.

**September 22, 2018** - NY Times writes story saying that Deputy AG Rosenstein discussed wearing a wire to record President Trump. The Times story also says that Rosenstein offered to recruit cabinet officials AG Sessions and Chief of Staff John Kelley to remove Trump from office under the 25th Amendment. In a carefully worded statement, Rosenstein denied the claim. The leak is suspected to have come from Andy McCabe's notes.

**September 22, 2018** - Trump is persuaded to back off his order to declassify and release all documents on the Russia Investigation. Trump instead, has deferred to the IG but has stated that the IG must produce his report before the midterms. Trump also says that two foreign allies have ask him not to declassify the information. Trump says "it's all coming out".

**September 22, 2018** - Papadopolous tweets out that the British Gvt. was spying on him and the Trump campaign by April 2016 and that Obama knew.

**September 23, 2018** - British music publicist Rob Goldstone tells congressional investigators that he doubts the Peepee story is true because he was with Trump 31 of the 36 hours that Trump was in Moscow. Goldstone calls the peepee story overblown.

**September 23, 2018** - Judicial Watch receives 70 pages of FBI documents that prove the FBI was paying Christopher Steele on at least thirteen occasions. The documents also reveal that the FBI admonished Steele in February 2016. Meaning, that Steele was working for the FBI at least four months before he began working for Fusion GPS.

**September 23, 2018** - Gateway Pundit story says that Lisa Page told congressional investigators that she believed Rosenstein was serious when he talked about wearing a wire and recording Trump.

**September 29, 2018** - House select committee announces that Deputy AG Rosenstein will be questioned behind closed doors about the accusations that he talked about wearing a wire to record Trump and also that he suggested putting together a 25th amendment plot to remove Trump.

**September 30, 2018** - After refusing to voluntarily testify to the House Joint Committee, Glen Simpson is sent a subpoena by Chairman Goodlatte.

**September 30, 2018** - The House Intelligence Committee votes to release over 50 interviews that were conducted during the last year in the Russia Investigation. The interviews include many former officials from the Obama Admin.

**October 5, 2018** - Former FBI General Council James Baker testifies behind closed doors to joint committee members including Jim Jordan and Mark meadows. Meadows and Jordan describe the interview as explosive and say Baker is the best witness they have interviewed.

**October 5, 2018** - Catherine Herridge of Fox news reports that James Baker named Michael Sussman of Perkins Coie as someone he met with, who provided him with information on Trump Russia and was essentially another dossier source. Sussman was a former DOJ official who represented the Hillary Clinton campaign in 2016 as a lawyer for Perkins Coie. Sussman is also the person that directed the DNC to contact CrowdStrike in April of 2016.

**October 6, 2018** - House Joint Committee interviews Trisha Anderson. Anderson was a member of the small group and was DOJ Deputy General Council. Anderson worked directly under James Baker.

**October 6, 2018** - The Hill's John Solomon reports that Michael Sussman passed documents and thumb drives to the FBI that was essentially the same information found in the Steele dossier. This activity took place before the first warrant on Carter Page was granted.

**October 6, 2018** - Solomon also reports that Baker admitted to manufacturing media stories, leaking them to the press, and then using those stories to sell the Trump Russia narrative. Solomon also reports that James Baker admitted that the FBI had "people" recording members of the Trump campaign.

**October 6, 2018** - The Hill article by John Solomon says that James Baker provided information about Deputy AG Rosenstein's comments about using the 25th Amendment to remove Trump, as well as the comment about "wearing a wire" to record Trump. Rosenstein is scheduled for a closed door hearing on Wednesday the 11th of October with members of the House Joint Committee.

**October 6, 2018** - The House Joint Committee issued and invite to James Comey to testify in a closed hearing. Comey's lawyer has stated that Comey wants an open hearing but only after the DOJ/FBI and DNI have decided what subjects are open for questioning.

**October 7, 2018** - Devin Nunes tells Fox News Maria Bartiromo that "The top Democrat lawyer gave the top FBI lawyer the Russian dossier that was used to spy on Trump".

**October 8, 2019** - The Daily Caller reports that an unknown Senator, contacted former staffer for Diane Feinstein, named Daniel Jones, in March of 2017, about continuing an investigation into possible Trump Russia collusion. Jones operates a group called Democracy Integrity Project, which is heavily financed by George Soros. Jones also worked with Fusion GPS and Christopher Steele. Jones was providing information to the FBI and democratic lawmakers.

**October 9, 2018** - The Hill's John Solomon writes that "the DOJ and FBI, Rosenstein and Wray, covered up, by way of redaction, key documents that implicate Hillary Clinton and the DNC in the frame up, the redacted documents had nothing to do with national security".

**October 10, 2018** - The US Gvt. seizes assets of Oleg Deripaska. Deripaska is believed to have been an asset for Comey, McCabe, and Mueller. Deripaska is also believed to be a person that corroborated the pee pee gate story.

**October 10, 2018** - The Washington Post reports that Rosenstein and McCabe got into an argument over investigating Trump just says after Mueller was appointed Special Council. The Post reports that McCabe and Rosenstein told each other that they should recuse themselves from the Russia investigation.

**October 11, 2018** - Deputy AG Rosenstein tells House Joint Committee that he will not turn over subpoenaed memos / documents to the committee. Rosenstein also cancels hearing that was scheduled for Thursday 10/11/2018.

**October 11, 2018** - Judicial Watch receives 288 pages of Clinton emails from FOIA request from nearly a year earlier. The new messages reveal three more classified emails that were on the Clinton private server.

**October 12, 2018** - Lee Smith of Real Clear Investigations reports that Bob Mueller and the DOJ (Rosenstein) filed a brief with the court that if Trump declassified and released documents sensitive to the Mueller investigation, that it would trigger a charge of obstruction against Trump. The DOJ informed the court that Trump had been advised of this.

**October 12, 2018** - Glen Simpson of Fusion GPS refuses to testify to congress. Simpson's attorney, Mr. Levy, says Simpson will plead the 5th if congress forces the subpoena. The House Joint Committee is investigating Simpson as a key player in the deep state coup.

**October 12, 2018** - Charles Grassley releases a document that reveals Hillary Clinton's request to relinquish her security clearance back on August 30th 2018. Cheryl Mills and four other un-named persons also relinquished their security clearances. All of these individuals had communication with Hillary's illegal and unprotected server, and dozens of other devices, where classified information was found. This is a result of an ongoing State Dept. investigation being conducted on the security breaches associated with the hacking of Clinton's communications.

**October 15, 2018** - By force of subpoena, Glenn Simpson of Fusion GPS testifies to the House Joint Committee. Simpson pleads the fifth. Mark Meadows says the committee will consider holding Simpson in contempt.

**October 15, 2018** - Carter Page sues the DNC and Perkins Coie as a result of the new revelations that Michael Sussman, lawyer for the DNC and Perkins Coie, gave James Baker documents and thumb drives with information regarding Trump and collusion with the Russians including the Steele dossier. The Steele dossier incorrectly identifies Carter Page as the key target and key player in the acquisition of the dossier from the Russians.

**October 18, 2018** - Judicial Watch receives documents that confirm that there were 340k emails between Hillary Clinton and Huma Abedin on the Weiner laptop. Also proven is that Peter Strzok hand picked and only reviewed 3000 of the 340k emails. This contradicts the sworn public testimony of James Comey.

**October 20, 2018** - Nellie Ohr invokes Spousal Privilege in a closed hearing conducted by the House Joint Committee. Ohr did not answer questions about her husband or any conversations she had with her husband. Mark Meadows said that little was learned in the hearing.

**October 18, 2018** - A deep state operative and Treasury Dept official named Natalie Edwards is arrested for leaking as many as 11 stories to BuzzFeed. Edwards leaked docs on Manafort and Rick Gates, also a man named Peter Smith who is now deceased. Smith had been investigating Clinton's State Dept. emails. Also implicated is a supervisor of Edwards believed to be Thomas Ott. Ott worked with Bruce Ohr at the DOJ and Bob Mueller's lead attorney Andrew Weissman at one time. Edwards crimes were discovered by the Treasury Dept IG.

**October 24, 2018** - Papadopolous appears on Hannity with John Solomon. Paps tells Hannity that he told Halper that he had no idea about Russian emails, told Halper that such talk was treason and that he had nothing to do with that and told Halper to stop bothering him about it. Solomon says Paps told the FBI this as well. Solomon says this exculpatory evidence was withheld from the FISA court. Paps tells Hannity he is going after the people that set him up.

**October 26, 2018** - Papadopolous tells Brian Kilmeade of Fox that he and his attorney are considering withdrawing Paps guilty plea. Paps says he believes he was framed by western intelligence, including US intelligence and the FBI. Paps says he reached the decision after information revealed in his interview with the House Joint committee.

**October 27, 2018** - Papadopolous sends out a series of tweets saying that he just learned that Bruce Ohr and Christopher Steele met in Rome the day after he was introduced to Joseph Mifsud in Rome. Paps also said that Bill Priestap was in London during the week that he had the conversation with Alexander Downer.

**October 28, 2018** - Papadopoulos tweets out that he and the congress both know who the spy was within the Trump campaign. Christopher Steele and Glenn Simpson both mentioned that there was a spy on the inside of the Trump campaign. Last Refuge is reporting that the spy may be former congressman and head of the House Intel committee Mike Rogers. Rogers was apparently brought into the Trump campaign in 2016 by Chris Christy. Rogers was let go from the campaign very quietly and without cause or reason just days after Admiral Mike Rogers of the NSA briefed Trump at Trump Tower.

**October 31, 2018** - Mark Meadows sends a letter to Judge Collyer, top judge at the FISA court, asking Collyer to investigate 1) Did the FBI abuse the FISA court. 2) Did the FBI weaponize the FISA court. 3) Did the FBI mislead the FISA court by using the Steele dossier to get the FISA warrants on Carter Page.

**October 31, 2018** - Papadopoulos tweets out and names the Israeli / CIA agent that gave him the \$10,000. that he (Papadopoulos) then gave to a lawyer in Greece. Paps suggest the Israeli agent was part of a set up by Mueller.

Paps says he will turn over the money to congress so that they can investigate the bills to discover their origin.

**November 2, 2018** - Papadopoulos tweets out that "the \$10,000. has been safely stored away after the likely asset trying to set me up did not want to take their money back after I told them to retrieve it. Am sure we can get the money to the committee for examination to see who was behind it".

**November 2, 2018** - Papadopoulos second tweet of the day says "I am more th

**July - 28, 2020** - Chuck Ross reports that a senior CIA analyst testified to the Senate Intel committee that it was Comey and McCabe that pushed hard for the dossier material to be included in the ICA.

**July 31, 2020** - Paul Sperry reports that former FBI GC James Baker said that there was constant dialogue between the FBI and the FISA court judges during the Carter Page warrant application process in 2016 and 2017. Sperry says it is not clear in what format or medium those conversations were recorded.

**August 1, 2020** - Paul Sperry reports that US Attorney John Bush is looking into the Obama Admins. To/From and About Queries related to NSA's upstream collections of FISA 702 data going back to 2015 and earlier, which includes collections involving US citizens and the use of that raw data by FBI contractors.

**August 4, 2020** - Lawyers for the owners of Alfa Bank have filed a defamation suit against Glen Simpson and Fusion GPS. Alfa's lawyers have petitioned a federal judge in DC to send a formal request to the British court system to force Christopher Steele to testify as a witness in the US based case against Fusion GPS. Alfa recently won their defamation case against Steele in Britain resulting in Steele having to pay about 70 to 90 thousand dollars to the owners of Alfa. Steele was given the false information about Alfa by Hillary's lawyer Michael Sussman. Sussman and Steele also gave the false info to the FBI, the NY Times, and Slate.

**August 4, 2020** - Redstate is reporting that US attorney from Missouri Jeff Jensen is probing the Mueller special council investigation led by Bob Mueller. US attorney from Texas John Bash is probing the unmaskings and the illegal 702 queries conducted by FBI contractors. Bash and Jensen's investigations are part of the overall Barr / Durham investigation.

**August 5, 2020** - Sally Yates testifies to the Senate Judiciary committee regarding the Spycgate scandal. Among other lies, Yates testified that the Trump team was not under surveillance. Yates was forced to admit that the FISA on Carter Page was based on fraudulent information and that she would not have signed off on the two FISA's had she known about the fraudulent information. Yates blamed Comey and agreed that Comey went rouge.

**August 5, 2020** - Multiple news outlets report that John Durham is preparing to interview former CIA director John Brennan.

**August 6, 2020** - NY Judge Sarah Netburn petitions a British court to allow Julian Assange to testify in a defamation case brought by Seth Rich's parents against Fox News. Journalist Ellen Rattner spent three hours talking with Assange back in 2017. Rattner told Ed Butowski that the DNC emails were given to Wikileaks by someone on the inside of the DNC....someone who worked there...a disgruntled Bernis supporter. Butowski then went on Fox and suggested Esth Rich was the person that leaked the emails to Wikileaks and this is the basis of the case brought by Rich's parents.

**August 6, 2020** - Paul Sperry reports that John Durham has been looking at Ukraine officials, the DNC and the Obama admin and how they coordinated to dig up dirt on Trump.

**August 6, 2020** - Gateway Pundit reports that Christopher Steele did meet with Ken Bensinger of Buzzfeed in January 2017 just before Buzzfeed published the dossier. Previously, Steele had complained about the release that occurred after David Kramer allowed Bensinger access to the dossier.

**August 9, 2020** - Lindsay Graham goes on Bartiromo following the release of transcripts of an FBI briefing to the Senate Intelligence committee on Feb. 14, 2018. The transcripts clearly show that the FBI lied to the committee about Steele's PSS and the validity of the dossier...just as they would to the FISA court five months later. Graham wasn't asked by Bartiromo why the members of the committee have never come forward after knowing they were lied to by the FBI at least dating back to the release of IG Horowitz's report.

**August 9, 2020** - Stephen Schrage also appears on Bartiromo. Schrage's name came up a year ago when we learned that Schrage was the one who put on the seminar at Cambridge and invited Carter Page. Schrage was a student at Cambridge pursuing a Phd and he was studying under Stefan Halper. Schrage says he has decided to come forward because it's important for the country to know what happened before the election. Schrage focuses blame on Halper, Breedlove, Steele, and the FBI small group. Schrage says the Flynn case caused him to go to Durham to offer his help. It is unclear why Schrage waited so long to come forward.
