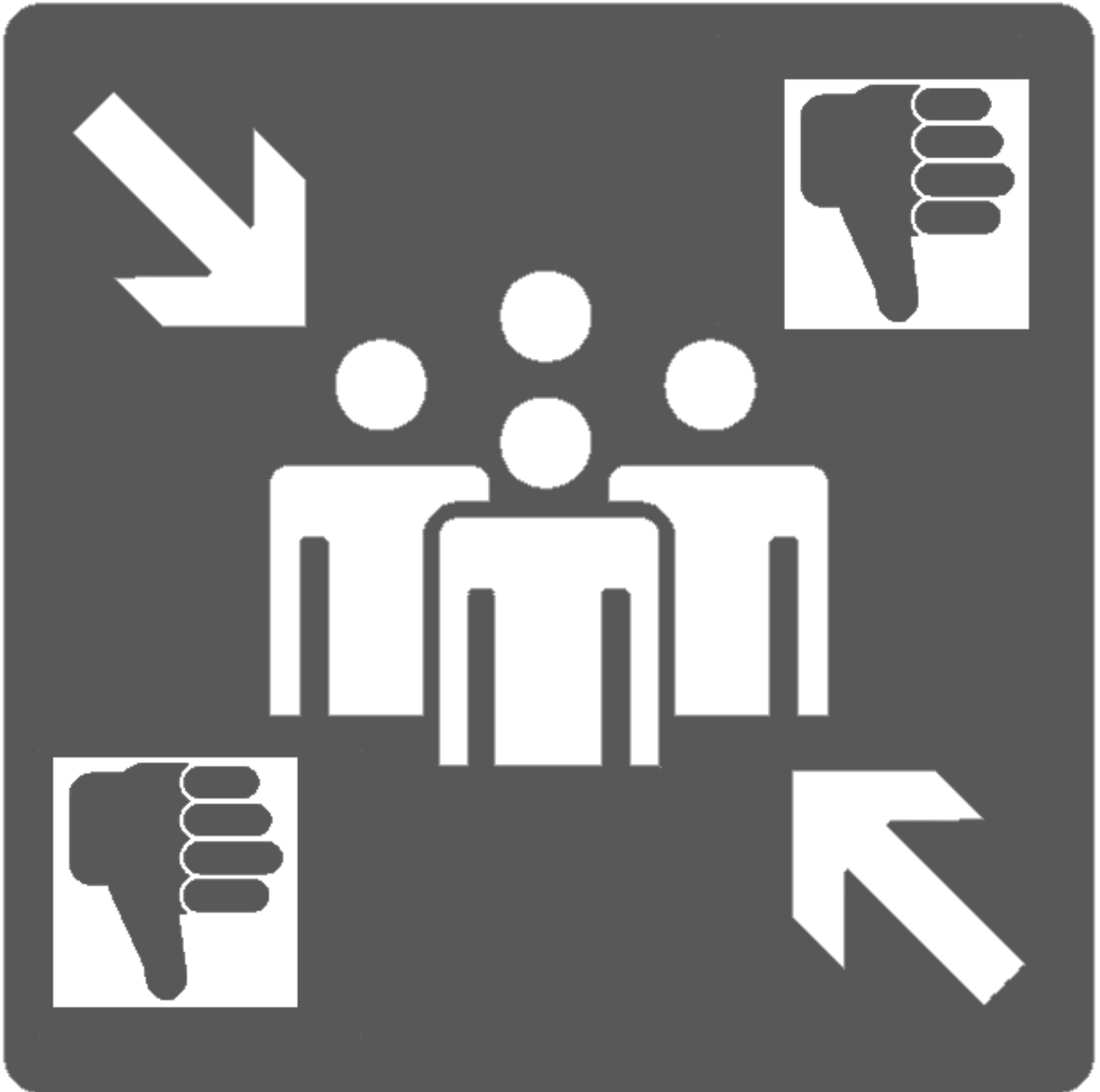

# Cancel Culture and Tribalism

## Preface

Cancel Culture Tribalism refers to a common social awareness phenomena where group members engage in a narrative that demeans a set of individuals or communities for having different values or characteristics.

CCT is a tool used by elitist groups for controlling the masses using the government, clergy and bureaucracy since they have the funding and the "right" connections within the media and the legal system. Governments may use cancel culture to increase their governance and budgets by creating animosity and divisiveness which in turns is a divide a conquer strategy. The media feeds on it because proliferating divisiveness sells circulation and ads and if the media advances its preferential side it gets government or elitist lobbies favoritism. The media and government may use CCT as a delimiting tool that ad-hoc acquires a bank or targets for a later use in the events that expose their methods or whenever they need an escape goat.

CCT nourishes itself by having a contagious mechanism that allows the recruiting new members or mobs by convincing them that adopting a cancel culture narrative would put them in an higher moral ground or may help their livelihood and survivability.

## **Disclaimer**

This book tries to portray the motives, characteristics and modus operandi within contemporary tribalism. This is a thesis which describes history in a subjective way by trying to understand what might be going behind the scenes using street- smart non academic- elitist language. It draws its conclusions by giving more validity to a financial or political outcome than the discourse of historians or journalists and the way they interpret history.

This work relies on motives, means and outcomes and not on what "scholars" and journalists call "evidence". We consider every fact checker organization or media outlet as an agenda gaslighter. What is known as common knowledge may be an outcome a biased interpretation of mainstream media and academy and can be disputed rightly so. Thus, it is up to the reader to validate, challenge or adopt the interpretation of the sequence of the events as described here or elsewhere and decide what part of this book is a conspiracy theory and what is a true conspiracy.

To understand the overall analysis, it is recommended reading the premise sections, and later on dive in into each chapter.

# Cancel Culture Engineering

## Premise

By definition, "tribalism" refers to a set of values within a common social awareness environment. Tribalism, differs from the concept of a "tribe", which alludes to a group of individuals. Hence, tribalism set of values may evolve over time even within the same group of people. Tribalism per se, is part of the human condition that has positive and negative outcomes. Tribalism is as old as the creation of tribes.

Cancel culture tribalism is an extension of tribalism where a group of members regard themselves as having higher virtues or are holding themselves in an higher moral ground when compared to non- group members. Cancel Culture Tribalism refers to a common social awareness phenomena where group members engage in a narrative that demeans a set of individuals or communities for having different values or characteristics.

This kind of tribalism may express itself by an elitist state of mind of contempt and despise of others, like the contempt and despise that some Ivy league professors and Antifa members hold on conservatives or the contempt that some Kibbutz members hold on orthodox Jews while pretending to be politically correct and on the right side of history.

## **Animosity Engineering**

Cancel Culture Tribalism, or CCT, refers to the kind of tribalism that uses and weaponizes the mechanism of delegitimizing outsiders for their values, beliefs, physical looks, economic class or race. This kind of delegitimization is justified with a moral high ground narrative which is called nowadays "Cancel Culture" which comes along with virtue signaling and critical race theory that has its goal tarnish entire communities by depicting them oppressors or exploiters depicting them as bigots or social leeches. Individuals that want to belong to a cancel culture tribalist group assimilate to the group or buy into their narrative.

From the beginning of human evolution and the creation of tribes, tribalism was an indoctrination process that created a justification for a tribe, tribalist group or nation to initiate an attack, tax or subjugate outsiders. Tribalism was created and implemented by tribe individuals as means of survival for the tribe or as a tool of gaslighting the fact that leaders are exploiting their subjects by overemphasizing a common enemy danger or a natural disaster that exists or doesn't exist. This in turn, pushed individuals to create or join a tribe or tribalist group as means of survival or enrichment.

This analysis is attributed to Ibn Khaldun's publications on tribalism as well. Ibn Khaldun was a pioneer historian in the 14th century who detected the phenomena of tribalism by studying "Atzabia", which stands for a neural system of common social awareness. He didn't elaborate on the machinery of awareness engineering that shapes and proliferates tribalism. Awareness engineering can be leveraged

by the the apparatus of clergy, government, education institutions, academy and media. Accordingly with this thesis, revolts and wars displace one tribe, a nation or a government with another in a cyclic manner.

Since revolts may occur after an emotional CCT campaign, the effect of the "dummy overtakes it creator" may occur. Emerging leaders like Stalin and Mao Zedong used the communist CCT to kill their co-leaders and to dismantle the Soviets that would overlook and guide their actions.

Physical tribalism is the kind of tribalism that doesn't allow outsiders to be integrated into a tribalist group, such an example would be the classic racism, the English royal family clique or black lives matter leadership. On the other hand, dynamic tribalism refers to a tribalism that allows outsiders to assimilate and become part of that group, such as religious conversion or socialist re-education like the case of Paulus becoming a socialist in soviet captivity.

Individuals may be part of various dynamic tribalist groups at the same time. Concurrent CCT affiliation especially in the digital age is common which provide an environment where a tribalist group member can belong to various groups simultaneously. This is done as long as the upper tribalist value which may be hidden, is not rejected by the individual and when the tribalist values don't conflict each other. In extreme cases when one CCT has more hate appeal over other two CCTs a CCT mob can be created by joining two contradicting CCTs like the case of extremist LGBTQAI+ and Hamas supporters that buy-into or are financed to follow CCT that share the narrative of tarnishing Jews by denying a Jewish right to live in a defensible state. Those double standards woke followers

depict themselves as an oppressed class defenders, while overlooking the fact that Hamas targets or may incite to murder LGBTQAI+ members.

Demeaning campaigns are considered persecutions, because they lead to shaming, ghettoing, outcasting, property and livelihood violation and in some cases bloodshed. These violent actions are done by the people who buy into these campaigns (mob) or pose as CCT followers. CCT instigators may be journalists, politicians, historians, prosecutors that use double standards and judges that were promoted by politicians or monopoly owners.

CCT instigators, use populist adherence campaign to carry out their plans, hate crimes or freedom infringements without them having to take any overt wrongful or illegal action. In this context, nations, think tanks, trade unions and the government apparatus (bureaucracy) are all regarded as tribalist groups that carry out at least one cancel culture agenda. The cancel culture tribalism is the mechanism that confines the limits of that group and defines who is an enemy or an eminent risk. This is because the cancel culture state of mind is what glues the group in a way that members give a preferential treatment to each other while taking advantage or delegitimize others. A group can be part of a bigger tribalist group.

Cancel culture may be upscaled to animosity engineering which is in effect a divide and conquer tactic that manipulates minds through brainwash to a level that enables contempt and the "disregard of the blood" of targeted communities and individuals.

## **Motives, Means, Opportunity and Evidence**

A motive to perform over- taxation, property right infringement, bloodshed or livelihood denial have a lucrative or a racketeering incentive. Human interactions are driven from basic needs of survival, self indulgency addiction, vengeance or power obsession which are morally laundered with synthetic "righteousness" through smearing campaigns.

"Morality laundering" accommodates a double standard judgement that justifies the non equal taxation, displacement, character killing and collective despise, livelihood restraint or killing of others by demeaning individuals or communities for their looks, rituals, beliefs, education or ancestry origin.

A portrayed evidence may merely be a "cancel culture evidence" may have a "shady", "shaky" or "conceptualized" flavor. "Follow the science" might turn out to be in hindsight "follow the science fiction" used to carry out a tyrannical policy. Similarly, "Follow the Expert" might be follow the Expert in the art of deceiving sciences. Follow the money may give you more information about the expert or scientist funding and his family and friends agenda. Since the expert rhetoric may be fabricated, gaslighted or taken out of context.

This analysis focuses more on motives and means of the human condition rather than the evidence as portrayed by the academy, clergy, education system and media. The justification for taking or taxing a resource of others may be done under the umbrella of religious, virtue- social justice such as Communism, "Diversity Inclusion and Equity" and Environmental Socially Governance ("Environmental Justice").



Many useful idiots buy-into those cancel culture narratives as a result of a brainwash campaign that convinces them that their livelihood, self indulgency or social acceptance may be affected by what they believe or show to believe in. They may become staunch believers that propagate the cancel culture making themselves as weapons of cancel culture contagious warfare.

Manipulation of evidence is done by omitting, forcing or bashing testimonies, forensic tampering, taking out of context as interpreted by prosecutors, media, clergy, governments, historians or investigators. In this way wars may start by the call of citizens to kill others and themselves in a war may be justified by incidents that governments, media and military take out of context, fabricate and weaponize for their on good or power obsession.

Accordingly with historian Frederick Merk the cancel culture of the "Manifest Destiny" was "used by Democrats in the 1840s to justify the Mexican- American War" which resulted in the annexation of vast territories including Arizona and New Mexico and the subsequent civil war. If president Polk had told congress that the skirmish with Mexico was south of the "Rio Nueces" which was a disputed territory the would be no casus belli to begin with. In this sense, war results expose the facts and evidence of a plot, more then the campaign promoted by a deceiving president and media.

The president the media and the state department were acting as arrogant control freaks that had a personal vendetta with Mexico after they couldn't convince Mexico's legislative body to sell them the territories of California, New Mexico, Arizona and the Territory that was south of the Rio Nueces even after

bullying Mexico with the forced one-sided annexation of Texas. Results are more reliable evidence than what gaslighting historians' and media label as "evidence".

Detecting cancel culture evidence can be done by highlighting a double standard narrative or a coverup campaign or tarnishing an escape goat. Cancel culture evidence is also used to gaslight favoritism in the process of tit for tat appointments of friends and family. Tribalism in many cases has financial incentives as exposed in the business model such as the intervention of a certain state department in other countries for the sake of enforcing a laundered international trade favoritism or racketeering, as was the case of the creation of Panama by tearing out Colombian land done by the American state department and the building of the Suez Canal by Britain and France.

## Governmental Tribalism

A neural system of common social awareness operated by the the apparatus of clergy, government, education institutions, academy and media "legitimizes" governance ruling and actions even if their actions usurp property rights and other freedoms. Hence, the most powerful group that relies on CCT, would be the government apparatus which paradoxically, also is responsible for the protection and prosperity of its subjects.

A conflict of interests paves a natural path to the eventual decay of the the government or the people in a cycle where the ruler and sympathized entourage increase the process of cannibalizing state resources for themselves for the purpose of indulging themselves or satisfying their hunger for self aggrandizement.. The oversight entities are becoming less effective because the government controls the Lawmakers and Human Resources entities that appoint, promote and demote the officials accordingly with its overt and covert policies.

## **Tribalism and Regulation**

Rulers indoctrinate their subjects to act on their behalf as their soldiers and the providers of government goods and services through slavery and taxation. Taxation is in effect a partial slavery which is quantified by percentage numbers.

Over-taxation is accepted by subjects because it is explained with the "Ask yourself what you can do for your country" narrative. In this regards, the "commonwealth" approach is bought in, since supposedly it gives the individual a feeling of controlling the taxation mechanism through vote and that taxes are needed to increase the "wealth of the common" which creates a notion that tax contribution is beneficial more for the state than for the apparatus. The mechanism that this tax submission is enabled is by the engineering of common social awareness, namely: Tribalism through media, police, education and clergy.

This taxation awareness has longer life expectancy if it includes cancel culture ingredients. Cancel culture taxation increases are accepted by subjects when it is coupled with another cation such tarnishing another nation, faith, political party (partisanship), inciting a "war against infidels" or tarnishing people that don't adhere to virtual signaling discourse. Accordingly, tyranny is the worst kind of statehood when it is virtual signaled, since government usurps property rights and rules with injustice against individual or community rights after gaslighting its financial goals.

When a state is created or undergoes a reset process through a revolution, new leaders bring the promise of better life for

the people. But over time, this promise is eroded by the needs of inflating the governing apparatus size and feeding its growing indulgencies. The apparatus need for resources increases also by the costs of creating and maintaining the optics that they working on behalf of the people through media, rituals, publications, academy and even law making. Congress members made millions in the stock exchange using inside information exclusive to lawmakers, even after creating restricting rules, because the judicial system and the FCC have double standards that protect the very people that appoint or oversight them.

As described before, civilizations have lifespans like individuals, and every state might eventually fall because sedentary luxuries distract them, and eventually government begins to overtax citizens and begin injustice against property rights, and "injustice ruins civilization". On top of that increasingly arrogance and power obsessions bring apparatus members to fight each other over the control of income and power.

Eventually, after one dynasty or royal authority falls, it is replaced by another, in a continuous cycle. The main actors that enable state cannibalism are actors from the military, clergy and governments apparatus namely the bureaucracy or government contractors and media class. Even in so called "Democracies" where puppets are replaced every four years, the effective ruler and resource usurper is embedded in the apparatus made up of bureaucrats and advisory class. The republic and the constitution tried to defend the individual against double standard prosecutors and judges, Nevertheless, President Adams circa 1800, the Federalist and subsequently the Democrat party had eroded those rights by usurping individual property rights with Federalism, progressist and

environmental narrative rubberstamped by double standard judges that had conflict of interests.

The overrun of the constitution by the Federalist movement took out the essence of the bill of rights. President Adams enacted sedition acts and packed the court with federalist and progressive judges while gaslighting his actions with belligerent rhetoric against Europe.

The fiscal control over individuals was achieved through ever increasing taxation and the creation of a federal bank and federal reserve to impose the control effectively killing the "right to liberty and the pursuit of happiness" which can't be achieved without free trade, the right of property and the right to choose livelihood.

Governments apparatus increases taxes and freedom on states and individuals with pretext of wars, progressive agenda and especially using an awkward interpretation of the commerce clause in the constitution that supposedly enable the regulation of commerce between states. Thomas Jefferson tried to remove the Federal bank apparatus and other tyrannical rules but subsequent governments created the second national bank and the federal reserve which were used as a Ponzi scheme to transfer control and purchasing power to bureaucrats.

Bluntly put by Thomas E. Woods: "(The power) to regulate commerce among several states ... was used to justify amazing and incredulous powers". This is because judges and lawmakers argued that every individual activity effects a specific "new" issue in commerce and therefore government usurped property and livelihood rights with new agendas

using controversial interpretations. Effectively, the interpretation of the this clause and other clauses by progressive and federalist judges extended the overreach or the powers of the government apparatus leading up to tyranny.

Tribalist instigators promote their agenda from their decision making positions held within government, judicial system, monopolies and military because they were appointed and promoted by the very same people that hold the same narratives and cancel culture mindset.

Ernest Gellner may have addressed the covert tyranny that is using different set of rules when it has to deal with insiders:

The Government apparatus is "an institution which prevents injustice other than such as it commits itself" using double standard judgement.

## **Cancel Culture Belligerence and Terrorism**

Tribalist groups have a set of narratives and values that define whether an individual can be considered a part of that group. At the beginning of history tribalist group membership was correlated to the physical membership of tribes and nations. A rebellion against tribalist values would mean death, arrest, losing a job, excommunication or paying more taxes or tributes.

Tribe leaders created or inherited a set of values that enforced certain rituals, pagan worship, behaviors and taxation or other donations such as obligatory military draft for the elder son or sacrifice of the daughter. In that era tribalism was a tool that gave cohesiveness, strength and unity to the tribe on one end and increased wealth and control for the tribe leaders on the other end.

Kings and leaders were used to control, unite and exploit tribe members through those rituals "moving the goal post" as they saw fit. Once a tribe encountered another tribe with different rituals, values or appearance, all hell broke loose. The propensity to an armed conflict was higher in cases where one of the tribes had a resource that the other tribe needed or wanted. This reaction was caused because leaders were afraid of losing their control mechanism through rituals or their livelihood in places where fresh water or other resource (such as oil today) was limited. This in turn created tribalist narratives that brought wars to the human kind sometimes with a domino effect that expanded into global conflicts.

A nomad tribe that came from the mountain or desert to a



stationary tribe area wouldn't be able to integrate with the static tribe, because the leaders of the latter wouldn't agree to share their patrimony, water or income flux. In such an encounter, a snowball hate effect might ensue between the tribes where most members would believe in time that their lives depend on the elimination or subjugation of the other tribe.

Accordingly with the Ibn Khaldun theory of tribe displacement, the nomad tribe would have more fighting efficiency per capita because of their adaptation to harsh conditions and lower addiction to indulgences. Lax and indulgence addiction is likely to increase over time in stationary places specially tribes located on port of entries or commerce hubs. In those places, rulers and their bureaucrats tend to acquire more indulgences on expense of their subjects or traders who pass through.

In many cases the leaders and their subjects would be convinced that the total annihilation of the other tribe is an existential matter in a sense that there is no other means of deterring other tribes of trying and conquer them other than total destruction setting an example to any future raider tribe. This in turn explains why in some tribes and religions massacre and pogroms are part of the survival rhetoric. CCT is the easiest tool to create a casus belli to take out the property and lives of the other tribe or to subjugate them with taxes. Whenever convenient, rulers disarm a war threat with a marriage contract between the rulers of the opposing nations or tribes. This is how we find peace treaties between Muslim and Cristian monarchies in Europe and Asia during the middle ages.

Such was the case with the tributes paid by Constantinople and Rome to the raiding tribes. Even United states was involved

with government indulgent bribes when paying tributes to pirate Berbers that seized or taxed their ships. The same way some argue that Carter, Clinton, Obama and Biden gave tributes and pandered theocracies like Iran and Hamas that kidnap their citizens because Democrats pander entities that have the power of increasing oil prices that would throw them out of power in the upcoming elections.

The indulgencies of Democrats are manifested in their drive and ability to increase the size of the government apparatus in a way that allows them to increase the funding and appoint more family and friends into bureaucracy, international outfits like the Clinton or Obama foundation, the academy, think tanks like "The Atlantic" and "Media Matters", Energy multinationals like Burisma, big-tech, media and progressive and socialist ONGs and companies that win government bids while increasing share value with congressional privileged information.

The bloodshed and Jihad in the Mediterranean is an outcome of a joint interest of theocracies and state department bureaucrats that have financial stakes in any barrel of oil that passes through Hormuz straights and Suez Canal. When oil trade routes are menaced by Iran and their proxies the State department, the academy and outfits like BDS or CAIR synchronize their efforts on creating media hit jobs that vilify the victims of Jihad or terrorist pogroms. Terrorist organization are funded and supported by western academies and state departments which strive to justify the destruction of a Jewish entity in the middle east in stages by reducing its defensible borders and demonizing Jews at the same time. Kissinger' "Let them (Jews) bleed" campaign that enabled the Yom Kipur had a goal of giving the Sinai peninsula to Egypt in exchange for free

navigation of U.S. ships in the Suez canal and the sale of arms to Egypt displacing the U.S.S.R in that market. In those cases, the governing class decided to pay bribes that would allow them to increase their indulgences rather than invest in a better fighting force or fortifications.

For expanding pre war hate agenda and increasing preparedness, rulers weaponize rituals and brain washing narratives through belligerence cancel culture tribalism, fabricated incidents or religious discourse. These kings and leaders convince themselves and their people that the other tribe or nation rituals or virtues are a proof that the other tribe existence endanger the mere existence or prosperity of their own tribe or nation.

In many cases these values are conflated to fit a fabricated or out of context incident, like the explosion of the "USS Maine" in Havana harbor right in times when journalist were asked to tarnish the Spanish army by American neocons and the state department. The same goes for the Marco Polo bridge sabotage in China, and the Glewitz radio station fabrication made by the third Reich which triggered World War II.

The outcome of tribalism may escalate in stages from social tarnishing, vote disfranchising, livelihood oppression and some time all it may result in bloodshed and even may lead to genocide. Such is the case of the Thule society publications and involvement in the German newspapers, academy, military and judicial system in the 1920s. The rise of the Third Reich is an outcome of a snowball CCT, that used the academy and media to spread a genocidal agenda using the print revolution and the radio and film revolution. In parallel to the indoctrination, the German junta of the Kaiser, Ludendorff and Hindenburg

blamed the Jews for their military defeat in WWI which escalated to WWII and the holocaust. For that matter the Kaiser was not trialed because he was a part of the United Kingdom royalty and was refuged in the Netherlands by the very same family. and In that case the German media and academy took a decisive role in the escalation and the metastasis that took place in the Tribalist ideology. Without the indoctrination of the media and academy in Germany, most Germans wouldn't be a complicit part in the genocide of Jews.

As opposed to that, a similar escalation process was interrupted twenty years before, at Dreyfus trial. by journalists like Emil Zola. Anti tribalist may pay with their lives or freedoms as was the case with Emil Zola, Salman Rushdy and Alberto Nisman.

The business model of tribalism in government strives at increasing government salaries and positions by creating new rules, laws and rituals using excuses that these rules are aimed at creating prosperity, security or environmental and social justice. On the same time, the Government apparatus is most likely to weaponize CCT for tyrannical purposes by increasing its budget and opportunities of appointments and tit for tat government bids. Apparatus members put themselves in higher moral grounds than their subjects because they assign themselves the "role" of being the "guardians of justice" and the ones who decide what actions extend the common survivability and commonwealth prosperity of the tribe or nation.

Consequently, tyranny in the apparatus increases overtime because the apparatus feeds itself with more people and

indulgences by the mechanism of double standard interpretation of the law. Aside for the motive, the apparatus has the means of collect information on all subjects and possesses the tools for fabricating incriminating or shaming evidence on whoever they consider being a risk. The apparatus uses a mechanism of human resource recruiting and promotion to decide what kind of friend and family would be part of the apparatus.

Basically the apparatus is a collection of states within a state. Today those states within a state are the state department, the judicial system, the military top brass, congress lobbies and the intelligence communities. All of those interchange information and decision making positions between themselves. This turns democracies in to "Virtue Signaling Elitocracies" instead of "Meritocracies" which is the ideal form of governments.

Such is the case with Aharon Barak who was a progressive chief of justice in Israel that appointed his wife as a chief justice while usurping legislative powers. In those cases the danger might be devastating because the apparatus controls the means of production through taxation and the prosecution and the policing force and the targeted individual has no symmetric recourse to self-defense. The apparatus can tailor a CCT hit job on every individual or community when their position in government is at risk or when they are not satisfied with the taxes they collect for themselves.

This mechanism was the business model of increasing the wealth of kings, governments and leaders. Whenever government budgets shrink, clergy, media or councils can invent new religious rules or statutory laws that would give them more excuses to levy taxes in the name of religion, socialism, progressism, environmental agendas or nationalism.

Cancel culture engineering protects the government from anarchy while it allows favoritism for whoever decides who and how to target its subjects

## **Progressive Cancel Culture**

Racism is form of cancel culture and not the other way around. This may entail that any cancel culture that is run by elitist groups could be dangerous, maybe almost as racism, because the elites have means, motive and opportunity to exploit or destroy others. Today many elitist groups use racism, social justice, environmental justice and other virtue signaling narratives to justify a cancel culture that is a coverup of a buildup of a controlling power agenda which has political and financial business models.

The open border policy has various narratives that aim at smearing conservatives by portraying them as racists while winning elections through undocumented voting, double voting, non-id voting, mail voting and election chaos. The rhetoric is that everyone that opposes illegal border crossing into the united states should be considered as racist. The business model of the Democrat government apparatus and especially the DHS is to allow the increase of budgets and personnel for "Immigrant processing" and blame the Republicans for not funding the DHS that intentionally is complicit with the cartels, illegal trafficking and other Judicial shenanigans. While doing so, non progressive workers of DHS are diverted to kinder gardening of trespasser families and caring for their humanitarian needs, instead of securing the border so more trespassers can go through.

DHS human resources increases managerial opportunities to woke workers while demoting conservatives with the kindergardening jobs. The woke progressive workers are enabling more illegal immigration through paperwork and

increase the rabbit hole that would include the funding and expanding humanitarian agencies that have to take care of the human trafficking consequences. # Academy and Media Hit Jobs

## Premise

In modern history, the media has the most effective means needed to proliferate tribalism and cancel culture narratives. Media can be used as a complementary multiplier tool for political persecution, government propaganda, election manipulation, religious discourse, polls manipulation, donation magnet, army promotion, judicial ruling, advertisement and human resources and academic preferentialism. The control of the people is done by "Media Hit Jobs" which may be used as brainwashing tools that leverage threats as well preliminary judicial hit jobs or lynch mob actions.

This is why democracies today are effectively "Mediaocracies", for which the use of the media to decide who can be elected and appointed and what agendas the government should follow with a double standard discourse and gaslighting media hit jobs. In a mediaocracy, the actions of the government are controlled and manipulated by "media operated charlatans", pollsters, academy "experts" and "media hitmen" that elitist people and conglomerates use to exploit the people or have self aggrandizement derangement syndromes like Stalin, some say the Clintons, Bushes, Obamas and Bidens and some supreme court judges.

Before the mediaocracy age, the most efficient tool of subjecting subjects" to government was enabled using clergy discourse, militarism and monarchy rhetoric or any combination thereof.

Cancel Culture Tribalism uses media to justify the preference of one group of individuals over the other by arguing that a group holds higher moral ground values or withholds preferential virtues such as heredity or academic degree or progressist inventions like demonizing people who use "binary" sex language. In that sense, media hit jobs are the most devastating tool of inciting one group of citizens against another and can incite civil wars. The media has an indispensable role in the Cancel Culture indoctrination by use of pejorative language and fabricated or out of context events. The virtual signaling enables an enhancement of delegitimizing of tribalist group outsiders. It even convinces bystanders to buy into their narratives.

## **Cancel Culture Media**

Media hit jobs are a pivotal part of cancel culture campaigns. Media hit jobs can be planned by publicists or can be an outcome of snowball effect made up by conflating an out of context event or even a tweet. Planned media hit job usually involve lawyers, governments clerk class or the military actors when those see danger to their position in government, contracts, political power or income.

The media can incite a war and be used as a tool for enlisting unaware soldiers needed to conduct these wars.

Enlisting New Zealanders, Australians and English people to be killed for Churchill in Gallipoli in WWI and in North Africa in WWII was done with Media Hit Jobs. The "white feather" media campaign tarnished young males that didn't want to kill themselves in a war for "king and country".

In many cases media hit jobs are created to gaslight and blame another party for the perpetrator own corrupt wrongdoings or double standard. Apparent this was case in Dreyfus affair, American Spanish war, Russiagate and Bidengate that resulted in the firing of Viktor Shokin in Ukraine for investigating a company where his son was a board of directors member. One may to detect a media hit job when a fabricated event or out of context event is simultaneously repeated in more then one mainstream media outlet, social media or academy or a journalist that owns mutual favors with the intelligence community or politician (mouthpiece).

Media hit jobs use Goebbels methodology of repeating a narrative so many times in many outlets. This has the effect

that even if an underlying event turned out to be false or misleading, the narrative had already indoctrinated and the audience was already brainwashed. It is dangerous because it can indoctrinate the audience to commit genocide or be involved in bloodshed against the targeted community or individual. As was the case with the killing of Paul Kessler. The judicial system in that case didn't want to charge the killer with hate crime, because it was pandering to antisemitic autocrats in the judicial systems, was afraid of the Muslim community or used a pretext that they don't want more antisemitic riots.

In those cases harming and tarnishing campaigns became contagious and viral and grow exponentially when used media, clergy and academy. On top of that the contagious effect is dangerous when using social pressure as well as implicit or explicit threatening the livelihood of people who question this narrative or decedents that don't propagate the mainstream CCT narratives which in many cases CCT campaigns are effectively hate speech disguised with virtue signaling and ornamented with wokeness and socialism. It is effective because CCT instigators use the media to convince the audience that the mainstream accepts the CCT narrativity cases non joining a tribalist narrative might imply endangering of a family, academic, journalistic military or political advancement.

Today most mainstream media outlets in Israel own favors with Judeaphobs and Orthodoxophobes actors, masked antisemites, international Muslim organization or progressive movements who all share common grounds with the JDS motivations. The JDS movement uses constantly media hit jobs against non progressive political parties and against orthodox jews or Jews living in Judea colluding with organizations like

BDS and other organizations that strive to destroy Israel or Orthodox Jews in stages using cancel culture tribalism.

They are funded by preferential government contractors, monopoly owners and international organizations. Their main actors involve front men that cover decision makers in trade unions, judicial, military, police and government clerk class that they appointed or that own mutual favors. They use HR double standard dossier manipulation and job history fabrication to decide who is appointed to the top military brass and the judicial system.

When cancel culture tribalism evolves from a passive mode to proactive mode it evolves into a stage of conceptual persecution. Conceptual or ideological persecution refers to a set of values that legitimize a delegitimization campaign that targets individuals or communities. It can generate a "peaceful" or violent demonstration or create a mob lynch event.

In many cases conceptual persecutions derive from a deliberate cancel culture campaign or ad hoc cancel culture tribalist event or a sequence of events. Conceptual persecutions may materialize into religious wars like the crusades or Jihad or Genocide like the Armenian genocide or the Holocaust. On the other hand conceptual persecution may be softer and unperceived and implemented by a mere denial of advancement or hiring of conservative or religious professionals in mainstream academia, media, high-tech and government. In those cases woke conceptual persecutions use the pretext of Diversity Inclusion an Equity or social justice to persecute the livelihoods or other freedoms like transit rights of people that don't accept their values.

## **Awareness Engineering**

According to Ibn Khaldun, prolonged state tyranny is likely to be facing a revolt or an overtake by another state whenever government apparatus exaggerates in increasing its power and indulgences on expense of their subjects. This in turn creates a negative sentiment of the subjects who in turn are discouraged to fight for their regime or produce goods or pay taxes realizing that the apparatus is exploiting them in an unfair way.

The missing link in Ibn Khaldun analysis is the understating of Cancel Culture Tribalism role in society. CCT is the tool that extends the lifetime of the apparatus and strengthens its cohesiveness. The cancel culture propagated by the regime removes the opposition and rebellion risk because dissidents might be afraid of being cornered to a dangerous position while non dissidents buy into government gaslighting campaign even when the apparatus is oppressing them in plain sight.

On the other hand, Ibn Khaldun proposed the theocratic state solution similar to a caliphate that would overcome an eventual decay of a nation or tribe. He proposes a form of government similar to a caliphate that might restrain apparatus decadence and tyranny. He argued that a state that cares about the afterlife and not current indulgences does not decay. He didn't take into account the centuries of bloodshed within and between the caliphates that was triggered by disagreements on the interpretations of the Koran, heredity issues or when subjects realized that clergy and Caliphs were using religion to indulge themselves or increase their power on

expense of their subjects. Those injustices and different interpretations made people resist or join a new emerging Caliphate, such as the wars conducted by the Mamelukes, Seljuks, Berbers, Shias, Abassids and so on.

In that regards one can argue the theocracies prolong the life of a state using cancel culture as well, since when a religion targets and demeans "infidels" or other religions this mere act by itself gives more power and control for the ruler through its clergy. The populous buys into the rhetoric based on an interpretation of divine gospel or divine law either because of fear or for the Stockholm Syndrome where a captive chooses overtime to believe and fight for what the captor believes.

The print revolution, the media revolution and the internet revolution gave the apparatus a tool of overcoming distances and time to convey their narratives efficiently and enforce their law. The most efficient way of dissemination of narrative and hate against outsiders in a tribalist environment is "outing" a characteristic of the target (true or false) that is suited to be "cancelcultured". When subjects use their feelings instead of their brains, specially in mob and social media environments, they tend to believe and protect the narrative even more then the rulers intentionally were counting on.

For "Awareness Engineering" to be effective in modern civilized environments, the government needs to work with the academy and media. All of them have a crucial role in the gaslighting and rewriting history campaigns by taking events out of context and fabricating and proliferating media hit jobs in a similar manner. The documentation of history is done by individuals that are part of tribalist groups within the academy, military and government who withhold certain agendas and

engage in coverups. They live in an ever expanding echo chamber which is a recruiting machine of people indoctrinated by the values their predecessors, fraternity, family or friends disseminate.

So called history scholars and government experts use many events that can't be scientifically proven or disproven in the full context, even when using secondary and primary sources. Basically, one can see that they engineer similar narratives in their echo chambers and propagate these narratives in the open using repetitiveness and out of context interpretation of events. Awareness Engineering propagation efficiency depends on deceit, timing, repetition and by planting agents in the audience, government or mob.

As soon as an individual crosses the lines of a certain cancel culture narrative, she/he is immediately pushed out of all the groups with a shaming campaign or targeted tax audit. Indoctrinated mob has no compassion, because social pressure, and has no violence limitations which will lynch or put the knee on the targeted neck with no quarters opportunity until the target submits or signs the admission papers that the intelligence community or indoctrinated prosecutors or the lynching media forces them to sign.

Artificial intelligence technology is taking ever increasing roles in media cancel culture campaigns. Technologies brought from the military and advertisement industry help the media, the government apparatus and the intelligence community collect, detect and interchange information that enables ideological persecution.



For the sake of simplicity we define AI as a system that collects information and uses algorithms that manipulates data and outlays the information in form that achieves specific goals. We may use the case of David Brock describing an AI SYSTEM that may have been created with the help if former FBI or NSA contractors or employees . For such purpose we may infer that Media Matters has a system of scanning and collecting tweets of Republicans or instigators disguised as Republicans in a mode that creates a database useful for that organization or the FBI. The goal in such scenario might be a creation a public notion that conservatives are a low grade class of humans with low morality. Thus in turn implies that you shouldn't vote for them or even harm their livelihood in the food chain of government, academy or intelligence workforce or management positions.

## Conspiracy Theories

Basically, a conspiracy is a plot of using covert or overt methods to increase a control over a resource, a government arm or a narrative. For that reason a plan or action that increases of purchase power of the "conspiring parts" on expense of others like a selling a product of a working hour may be considered in many events as a "conspiracy". A product transaction or a working day what have non market pricing may be considered "conspiracy" because the service or product provider or the counterpart increase their power of purchase on expense of others assuming that the money supply in the market is limited in a certain point and time.

Money supply is denominated by economists M1, M2 and M3, and is controlled by the federal reserve and the banking system in a way that puts their decision makers as Ponzi schemers that increase their power on expense of the people purchasing power by using interest rates and printing paper. Today economies and societies can't function or prosper without all those "small conspiracies" and "big conspiracies" that have the role of white cells in the body of nations and it is what keep those societies living through trade and production.

The money supply "Ponzi scheme" is what maintains the government afloat because without that mechanism government would not be able to contract services or raise taxes or run the apparatus of law and order like the army, police, intelligence community and the injustice system. The Ponzi scheme of the Bank of Illinois that was a state arm of taxing people was dissolved after being exposed and caused the duel between Lincoln and Shields. Paradoxically, Lincoln

increased the federal banking system power and taxes after years of criticizing the very same banking system on the state level.

Influence peddling which is the embodiment of tyranny that occurs within governments and human resources departments is a conspiracy that the government works hard to hide by blaming whistleblowers with conspiracy theories or creating a judicial or media hit jobs against them using fabricated or out of context dossiers that exist in their databases. So in that regards, every trade interaction, hiring or taxation may be considered a "conspiracy" in those environments. Taxation decreases the power of purchase of the taxed target and increases government control and its power of purchase. If the government uses this power of purchase to indulge a bureaucrat or appoint friends, family or tribalist member in bureaucracy the government has just deceived its constituents. Nevertheless, without that mechanism of taxation, appropriation legislation and "fair oversight" the government can't govern and chaos may ensue. Chaos or rebellion would occur when the number and extent of influence peddling reaches a breakpoint level. This is why the government is recycling news and media hit jobs in a manner that prolongs and expands its governance.

When a journalist or scholar uses the term "Conspiracy Theory" or "Fake News" the goal is to persuade the audience that an objective "fact checking" concludes that there is no plot. In many cases the persuasion works because most audiences live in their echo chamber where there is no need to disrupt a comfort zone or vet whether the journalist or academy hack is a narrative conspirator or that she/he is not complicit in a smear campaign. In many cases the "fact

checking" would focus on a side event or smearing a whistle blower and not on underlying tyranny or the mischief that should be investigated or condemned. Most audience and government contractors and workers don't have the time, the means or the will to leave their echo chamber and comfort zone and may even propagate these biased narratives for obvious reasons like self conscience, social acceptance or livelihood survival.

In some cases people and especially journalists double down on any attempt that tries to show their beliefs and allegation were made upon wrong assumptions or fabricated news. That is the very time they use the term "Fake News" or "Conspiracy Theory". Journalists, pollsters, politicians and historians know that there are so many facts that can be forgotten, hidden, downrated or taken out of context in a way, that the masses can't recall or connect all the dots that would demonstrate their bias or corruptions. This is why they focus on creating landmark events that are pushed in a synchronized way in many media outlets using political advertisements and bots accentuated retweets while shadow hiding what might disclose their purposes.

A similar way of shadow banning is the double standard use by the judicial system, government prosecutors, party lawyers and intelligence community using spying and judicial hit jobs whitewashed by FISA courts (Foreign Intelligence Surveillance Act) that try to prevent whistleblowing or label whistleblowers as conspiracy theories for the purpose of hiding their conspiracies or corruption. In these cases the surveilled target texts are selectively copied and pasted out of context in a way that allows indicting seizing property, arresting, harassing, coercing or auditing a target until a testimony or "admission"

are achieved. The intelligence community can redact whatever is not convenient to the judicial system with the excuse of hiding methods, protecting others or national security which in fact gives the government or securocrats a tool that nullifies the Fourth amendment can conduct hidden tyrannical measures.

Pollsters fabricate numbers because the questions they ask, the community asked and the formulation of the questions are driven by their agendas and because people are afraid of expressing conservative ideas. Conservatives or non socialist people in China don't want to be targeted by the government or don't want to be socially outcasted by the woke mainstream media and human resources departments in their workspace. Such is the case that in the intelligence community most workers, especially decision makers, and comptroller personnel disclose to which party they donate.

In some cases pollsters may indicate what are the necessary "counting" or "canvassing adjustments" needed to win an election before and during the elections setting the outcome which in many cases they make us believe that the race is tight. Adjustments are enabled because the algorithms of the counting machines, and the disqualifying or counting methods can't be done on every vote specially where there is mail voting, non-id voting, Corona voting, non traceable voting and where regional or ballot ballot chairs in critical places are appointed by a specific party endorsement. To some it up one can argue that "vote doesn't count and the counter votes" while pollsters set the guidelines on how to count.

# Antisemitism

## Premise

The origins of antisemitism can be tracked all the way back to the Pharaonic dynasty. In those times the dynasty created a narrative that the Israel tribes might join an invading force which would displace the Egyptian people. The narrative enabled over taxation, enslavement and Jewish round up in "Goshen", which was the first documented Ghetto. Antisemitism is weaponized in politics, financial overtake, racketeering plots, corruption scandals and wars. Antisemitic leaders blame Jews in events that where Jews are victims of persecutions, smear campaign or murder. Goering blamed and overtaxed jews for the pogroms committed in Kristallnacht.

Jew communities are an easy prey because their appearance is detectable and their neighborhoods or ghettos are well confined. Their hate is overwhelmingly indoctrinated in gentiles hearts in many places and times by the most contiguous documented cancel culture tribalism in history by the clergy, nobility, governments, academy and progressive movements. Tribalist leaders and hate inceptors use Jewry as escape goats to recruit followers or pogromist or demonstrator mobs as part of political campaigns or gaslighting campaigns. This is why media, clergy, political parties, and governments often used as escape goats to deal withThey have a different appearance and rituals that make the easy pray for pogroms, Ghetto round ups and defamation plots. They are the ideal target for massacres because they restricted movement and livelihood is enforced by Cristian or Muslim clergy, kings and caliphs or non-puritan dress code communities, Those restrict

any self defense use of weapons and organization as well as limiting free movement and trade as well as geographical expansion, land acquisition which are basic nation means of survival.

Antisemitism may proliferate to places with no jews through the use of newspapers, academy, clergy and social media.

The Holocaust in Germany in the 1900s, Britain in the 1200s and Spain in the 1400s ware a direct result of a smear campaign and sinister conspiracy that took advantage of economic and social conditions and used the confluence of various types and levels of European antisemitism indoctrinated in all levels of society.

There are five basic forms of Antisemitism that are categorized accordingly with their desired outcome, reasoning and inception methods. They have thin separating lines. Brainwashing, economic incentives and social pressure change individual reception tendency by adopting and preferring one kind of antisemitism over the other accordingly with the prevailing circumstances. Individuals might adopt more then one kind of antisemitism at the same time. Each type of Antisemitism can spread and evolve very fast to a more dangerous form. Therefore, governments that don't block any kind of antisemitism are doomed to be complicit, endangered, converted or participant in hate crimes.

## **Antisemitic Tribalism**

Cancel Culture Tribalism may be the basis of proliferating antisemitism, orthodoxophobia and Jihad. In such cases, cancel culture is used to justify the shaming, harming, deportation, rounding up in ghettos or concentration camps, livelihood exploitations, bullying or direct/ staging genocide and pogroms like the inquisition, October 7th massacre and the holocausts. The executing mob and government officials would be performing those atrocities after being indoctrinated by a narrative of divine guidance or academic moral high ground brainwash like the Third Reich and the lynching of Leo Frank. The cycle of persecution would be extended to anyone who questions or is not collaborating with the narrative by threatening their livelihoods, smear campaigns or being rounded up in prisons or concentration camps.

Antisemitism is a belief that Jewish individuals or entities should be subjugated, have limited circulation, taxed, or removed (destroyed) on the allegation that all Jews supposedly pose existence threat on a nation, humanity, religion or progressist ideas. It can be found in Europe 15th century printing, Social Darwinism, literature in Arab nations and National Socialist publications. Perpetrators of such an indoctrination use their subordinates to collect Jewish assets while mass killings are taken place. Goebbels was an indoctrinated and indoctrinator of this kind of hate and killings. Indoctrinated antisemitism is the form where planned mass murders occur and it is done by recruiting or up-scaling other forms of antisemitism by brainwash or economical incentives or social pressure.



These narratives may manifest themselves in Der Sturmer, protocol of the elders of Zion, Marxist and progressive papers, and clergy papers like Martin Luther and Amin Al Hussein, Arab and German academies, public education curricula like in Egypt, Iran and schools run by UNRWA, mainstream media, in even in some Ivy league academies, Hollywood. Ivy league academies and to some extent Tel Aviv university and high schools are effectively controlled and funded by antisemitic and intrasemitic entities that push the colonialist antisemitism which indoctrinates alumni the narrative that Jews would be exploiting Muslim lands instead of the other way around. To be promoted as a professor or have a good grade, or acceptance of published papers and dissertations that portray the Jewish exploiter narrative in a similar way done in Munich and Nuremberg universities in the beginning of the 20th century.

The mis-use of the justice system to imprison or kill Jews can be found in hate driven prosecution embellished with spy plot, treason sexual exploitation or financial exploitation fabrication. In many cases the trial is a cover up plot that conceals the real perpetrator from within government apparatus who holds mutual favors with the prosecution actors. In many cases the outcome of the trials is decided before the verdict. Judges agree comply with the agenda when the apparatus uses and overzealous deterrence and vendetta campaign that the police or intelligence communities or governments want to project on what might be considered as risks. In those cases indoctrinated lynch mobs and media mobs use instigators that bribe or tint judge, jury and mob judgements. Such may have been the case of the killings of Leo Frank, The murder of Rosa Luxemburg, Rehavam Zeevi, Kurt Eisner and Ethel and Julius Rosenberg. In many of those cases a spy plot is injected into a media hit jobs and trial process because it is easy to create

fabricated or unvetted "classified information" as well signed coerced admission or testimony opening can of warms on every person of interest.

Anton von Arco auf Valley, justified the killing of the prime minister of Bavaria in 1919 with the argument that Eisner was "a Bolshevik, he is a jew, he's not a German, he doesn't feel German, he is undermining every kind of German feeling, he is a traitor". This actually is the whole Mein Kampf in a nutshell before the Beer Hall putsch. This narrative was already indoctrinated in Germany in beginning of the 20th century which confirms the theses that the holocaust began at the beginning of the 20th century and not in 1941.

The irony is that the killer was obsessed with his Jewish background, being excluded from Thule society because of his Jewish converted mother. The Thule society was the funding and indoctrinating organization of the National Socialist party that controlled the Frei Korps and the judges that put Hitler in the same cell of Eisner's killer and were in charge of the short sentencing and parole given to those antisemite killers. The Thule society funded and bought the newspapers that were in charge of disseminating genocidal cancel culture antisemitism. Basically, one can argue that the Thule society and similar think tanks were the main responsible for the Holocaust because it takes a cancel culture campaign to convince a group of people to kill or round up another people. The pure performance of the Nuremberg trials sent to death only Julius Streicher for indoctrination crimes and didn't hang Rudolf Hess for the same crimes as well as Albert Speer who was in charge of the holocaust industry and enslavement program.

Moral high ground narratives need academy, ONGs or clergy

to implement and plan the spread of their agenda. Both weaponize the harming and overtaking livelihoods their victims while vilifying the Jews as the aggressors. In some contexts the internal hate of radical socialist and progressive Jews against revisionist or orthodox Jews has similar motives and characteristic then the antisemitism, but is classified as intrasemitism.

The Holocaust was a result of a smear campaign and sinister conspiracy that took advantage of economic and social conditions and used the confluence of various types and levels of European antisemitism indoctrinated in all levels of society. Antisemitism was and is incorporated in politics, military, trade and governance through the use of media, clergy and the judicial system.

There are five basic forms of Antisemitism that are categorized accordingly with their desired outcome, reasoning and inception process. They have thin separating lines. Brainwashing, economic incentives and social pressure change individual beliefs by adopting and preferring one kind of antisemitism over the other accordingly with the prevailing circumstances. Individuals might adopt more than one kind of antisemitism at the same time. Each type of Antisemitism can spread and evolve very fast to a more dangerous form. Therefore, governments that don't block any kind of antisemitism are doomed to be complicit, endangered, converted or participant in hate crimes. The basic forms of antisemitism include:

## 1) Woke Antisemitism

Woke antisemitism tries to propagate hate for Jews using academic or mainstream media rhetoric by portraying Jews or Israelis as a risk for other religions or social classes by way of scientific research, academic writings, clergy preaching and judicial and media hit jobs. The main purpose of this kind of hate instigation is Academic acceptance or media and social acceptance. Woke antisemite instigators may be politicians that want to recruit followers or be contractors that receive financial incentives or influence peddling benefits and may be paid by antisemitic ONGs or media outlets. Woke antisemitism is also used as a tool of increasing devotion and religious adherence and mindset control. Woke antisemites are fixed on their narrative of history and are very narrow-minded in their echo chamber.

Woke antisemitism uses Critical Race theory, anti colonialist narrative and cancel culture that victimize terrorist groups and people that give aid and comfort to Jihad supporters. Both the woke antisemite and the "patronized victims" deny the right of Jews to live in the holly land in a defensible border by portraying religious Muslims or antisemitic Arabs that terrorize Jews as Apartheid victims and not as violent demonstrators that murder or risk the lives of Jews like the 1929 pogroms. Both disseminate and fabricate out of context events of settlers violating Arab rights for the sake of gaslighting terrorism made by Arabs that don't recognize the state of Israel or the right of Jews to live peacefully in the holy land. Many woke antisemites engage in denying, justifying, underrating or projecting the holocaust on its victims.

They try to hide their goal of by delegitimizing the safe haven that would save Holocaust survivors from a Second holocaust. The risk of a Second holocaust may be have its roots in the continuation of the programs conducted by Arabs in Jerusalem and Hebron in 1929 through the pogroms occurred in the Negev in 2023. The eventuality depends on aid and comfort that the west and the united nations are giving to terrorist groups that say to represent 500 million Muslims interest in the holly land and control their oil supply.

This kind of antisemitism was perpetrated by a gentry Englishman Houston Chamberlain who was the personal Kaiser's guide on antisemitism and the best seller publication writer of hate speech (which preceded Der-Sturmer) until 1927. Later on, this narrative gave open check for killing Jews to the FreiKorps, extremists and the German Workers party (DAP). Farrakhan, Hamas and Iranian narratives are an expressions of Rhetorical Antisemitism. The Iranian regime, Spanish church in the 16th century and Russian Tzar-Cossacks plots belong to a more radical antisemitism which agrees on taking Jewish property for that reason. The justification is the exploiting race narrative used in the protocol of the elder if Zion, Mein Kampf, Martin Luther publication and Das capital.

According to polls more then 50% of 18 to 24 years old in America agree with the elimination of a Jewish state converting it toa Muslim state. This comes at times that decision makers in colleges promote or enable the "From the River to the Sea" agenda. It happens because the tribalist groups of colleges are funded and indoctrinated by cancel culture progressists and antisemitic funders.

In the progressive and socialist tribalist agenda the uppermost

According to polls more than 50% of 18 to 24 years old in America agree with the elimination of a Jewish state converting it to a Muslim state. This comes at times that decision makers in colleges promote or enable the "From the River to the Sea" agenda. It happens because the tribalist groups of colleges are funded and indoctrinated by cancel culture progressists

and antisemitic funders.

## **2) Xenophobic Antisemitism**

Xenophobic antisemitism is characterized by hate and fear feelings that takes place in the initial encounters with jews or the first encounters of the idea of Jewish existence. It can surge after an encounter or TV report where a Jew is depicted as an obnoxious or weird person. The feeling manifests itself when a subject sees a different dress code, appearance or religious rituals. The urban legend "Jews drinking Cristian children blood in Passover" weaponizes, proliferates and propagate Xenophobic feelings that may cause genocide and other liberties infringements.

Xenophobia can be reinforced by tales at the education system, family, theater plays, clergy within childhood environment, work and military circles. It gets deeper when the real encounter with real Jews occurs if other people who hate Jews are in the social environment when this encounter occurs. It has more impact if the individual absorbs this hate from a role model or important figure. If the Xenophobic hate and fear is exposed on various media outlets at the same time it has a faster and more longstanding impact. A similar reaction would occur on the first encounter of an indoctrinated kibbutz member with orthodox jew. The driving force of propagating and the acquiring of this kind of hate is social acceptance or intellectual or religious acceptance, but in that case the hate is feeling under the category of intrasemitic hate and not Antisemitic hate.

This kind of antisemitism was propagated in printed publication back to the era of Martin Luther. Xenophobic Antisemitism existed when German troops faced a cultural



shock while meeting poor orthodox Jewish communities for the first time during the occupation of Poland, Ukraine and the Baltic after Germany defeated the Russian army in 1917 at the "Ober Ost".

Ober Ost was the plan to make Poland, Estonia, Ukraine, Lithuania and Latvia a territory that would be ruled and settled by German soldiers. In effect it was governed by Freikorps troops even after Germany surrendered to the west where xenophobic and economic of antisemitism encounters occurred. The same Ludendorff was the German Junta leader that participated in the Beer Hall Putsch in 1923 and the one who propagated the Jewish "stab in the back" antisemite cancel culture hit job.

Some Jews tried to avoid Xenophobic antisemitism by changing their appearance and customs and adopting cultures and cancel cultures like Hellenism, reformism, Christianity, Islam or Socialism or LGBTQAI+ looks and supporters. While doing so, they fall in a rabbit hole that makes them tools that give aid and comfort to terrorists or genocidal antisemites that throw them under the bus when the time comes.

### **3) Vindication Antisemitism:**

This kind of antisemitism is aimed as a cover up or gaslight a crime, corruption, treason, political abuse of power or other misdeeds. It embeds the classical fall guy entrapment and blame game. When a ruler was searching for some others to blame as a deflection from the possibility of being overthrown Antisemitism was an easy way out.

These anti Jewry narratives were adopted by the military German Junta and academy. Hinderburg, the Kaiser, and Ludendorff adopted Rhetorical Antisemitism as an explanation and cover-up for the result of the WWI outcome and the economy. In some cases a religious, commercial or military incident which involved hurting Jews may raise a vindication theory that uses antisemitism to heal the consciousness dissonance or narrative. It is a retroactive free check for misdeeds committed in the past or for an ongoing process. These individuals or groups may later on be more willing on indoctrinating and preaching for a wider or more dangerous kind of antisemitism. Such is the case with Houston Chamberlain that published antisemitic editorials after a feud with a Jewish loan entity.

#### **4) Antisemitism by Convenience:**

Job security, academy advancement or lucrative dealings may be achieved when proliferating or expressing antisemitism or just murdering Jews. The Palestinian Authority, Hamas and some ONGs in Europe and the United State fund terrorists or their families or fund the indoctrination of campaigns the aim at terrorizing Jews and entrap jews in media hit jobs using United Nations facilities or mainstream media. In some working environments bureaucracy and academy acting or proliferating antisemitism may ensure job security or job promotion.

Forfeiting debt and rent may be considered as a lucrative-antisemitism since it generates pure gains. A road-map on how to make a judicial plot for generating economic gains can be traced back to Shakespeare publication of the Merchant of Venice. Ilhan Omar's antisemitism is a mix of Lucrative (Political gain and contribution gains) and Clergical antisemitism (ideology that came from religion and education).

Throughout history Jews were an easy prey of demagogy, military blunder escape goats, clergy, public opinion smearing campaigns. As bigger the blame rhetoric could be conveyed to the public, Antisemitic spread and deeper adherence could be achieved. All these types of antisemitism existed in all German population classes during and before the great wars. The sixth Nuremberg trial concluded that without the active participation, funding and production capabilities, the chemical, pharmaceutical, industrial ( and media ) of German companies (Bayer, IGFARBIN, Benz, BMW, Porch, Messerschmidt...) the Nazis wouldn't be able to rise to power

and conquer Europe and execute the final solution.

Extreme hate fanaticism which involves government systematic mass killings was to exist in history under indoctrinated antisemitism only. They occurred after catastrophes, plagues, church inquisitions or as a result of war. The third Reich took it to the next level using mass media “Hollywood tipe” propaganda and mass killing engineering.

Antisemitism was propagated by the ruling class academy, court, military (Dreyfus affair), industrial complex, politicians, clergy, judicial system, press and academia. A governmental sponsored mass killing of Jews wouldn't be achievable with at least three of these entities working together. The idea that only the SS committed the holocaust is refuted by recent studies and Nuremberg trials. Wehrmacht and industrialists were enthusiastic on carrying out the mass killing, property overtake, deadly slavery and human scientific experimentation.

Holocaust mass murder actions are traceable back to 1918, when German soldiers and officers executed Jews with Ukranian citizens help. Those soldiers will later on join the Freikorps and the Wermacht. The occupation of eastern Europe by Germany had enabled the military a much needed allocation of troops to the western front in France as formulated in the Brest- Litovsk agreement. Those were desperate times in the east where almost no food and other materials were available for the local community because of the long war going on. The most efficient form of military occupation and control was the use hate between ethnic groups while blaming the Jews for the hunger and economical condition. This explanation gave a free check to civilian attacks and loot on Jews with German troops help while Germany was

plundering food, raw material and goods from occupied Eastern Europe.

It was easy to find Ukrainian people who were happy to adopt the blame theory in order to kill, deport and seize Jewish property in those desperate times while sharing the profits and putting together shooting squads. The German army appointed local policing individuals that would help these new “pogroms” both in 1918 and in the 1940s concentration camps and next mass graves. This form of combining technique and rhetoric was also promoted by Russian Tzar pact with Cossacks where the government got a percentage of the loot made by approved Cossack Murder groups. Pogroms were many times backed by the Russian church and Russian aristocracy and intellectuals support.

The roots of the Holocaust systematic mass murder and rhetoric are traced back to the Brest-Litovsk era when Germany occupied Eastern Europe and had soldiers shooting squads killing Jews in 1918. One year later German military oligarchy and Hitler formulated a paper that uncovers the idea that the achievement of total Jewish removal can be achieved only by systematic action run by coordinated antisemitic government and not by sporadic actions run by part of society known as ‘pogroms’.

Until today there is no real answer on what were the events that led the Fuhrer to believe and promote indoctrinated-Antisemitism.

There is no conclusive explanation what was the event and process that made Hitler to be antisemite at all. There is a theory that Hitler acquired antisemitism after he realized his

actions in the front-line as a survivor military courier were he took credit for a Jewish official action. What is clear today, is that a precondition for work for the German counterintelligence or to be working for the military oligarchy the “Backstabbing theory” and antisemitism were a must.

The German Military command after WWI adopted Ludendorff rationale of the “backstabbing theory” that blamed Jews for German war surrender. It was part of fighting against Bolshevik ideology and political threat. Scarce Military job positions were given in counterintelligence community to people who adopted this ideology or could indoctrinate it as part of the military would be accepted. In 1918-1923 Germany faced various coup d’etat attempts and had to deal with civil deadly confrontations which involved Freikorps troops and extreme right and left groups.

After formulating the 1919 letter of the “government Jewry removal plan” and other publications during work as propagandist and orator for the DAP more ideas and help came for writing discourses and Mein Kampf . Assistance came from Rudolf Hess, Bavarian- Prussian generals, intellectuals including gathering materials and ideas from Houston Chamberlain, Eckert , Alfred Rosneberg and even Martin Luther. He was transformed from an Indoctrinated Antisemitic to Indoctrinator. In these years after jail time there was a transformation process that from a Manchurian candidate for the Military oligarchs and the NSDAP he became their leader up until 1945.

“The antisemitism of reason must lead to a struggle for the legal battle to abrogate laws giving [Jews] favoured positions, differentiating the Jew from other foreigners. The final goal must be the uncompromising removal of Jews altogether. To

accomplish these goals, only a government of national power is capable, and never a government of national weakness.”

Hitler gained trust from the military oligarchy in 1919 by composing a letter that expressed their antisemitic ideology that was already existing in the military leadership think tank. He was sent by his superiors to “infiltrate” the DAP headquarters (German Working Party) with the pretext of protecting the nation against extremists. They shared the same narrative about the war and Jews as expressed by DAP founder Anton Drexler . Conveniently, he became its leader and transformed it onto the Nazy party and thereafter attempted the 1923 coup which tried to bring Eric Ludendorff the WWI war monger antisemite to power.

Most historians agree that the Holocaust was part of WWII which is a result of the fallout of WWI. There were about 30,000 printed books that try to explain the origins and the real development of the war but there is no agreement within these theories on what was the main cause. Most agree that it was an event that was a confluence of other events and aspirations of rulers and the masses that sought an expectation of changing world order or social justice. Sarajevo murder of Franz Ferdinand was not a reason for a global conflict, it was just the trigger of many adversities and confrontations that were about to explode in many regions, No one was expecting the chain reaction and the intensity that would be to occur simultaneously with the unpredictable

violence and time expectancy (Sleepwalker effect). Even though the scale and shape of the war was unpredictable all major participants were eager to wage war and were stocking arms, horses, other means of transportation and reading their manpower and economy for a major conflict. The common rhetoric was that the powers were arming themselves and getting ready for a “defensive” war. Generals and politicians knew there was a competition for global resources, trade lines and colony expansion.

After WWI rising opponent politic groups were getting violent by the day ready to use all means necessary to destroy their opponents. Germany of 1918-1919 was in civil war both ideologically and literally. The ideology that would be more persistent, ideology persuasive and violent would be able to get the power after destroying or converting the enemies.

After the armistice of 1918 Germany fell in economical and political chaos of starvation. It was obvious the the German Junta which was in charge of Hindenburg an Ludendorff was the agent of the economical and war disaster brought on Germany and its neighbors. They adopted the rhetoric of their Kaiser that the Jews were the reason of the backstabbing in the German people, The blaming of Jews was a must for the generals and what saved them from public lynching or deportation (as occurred with the Kaiser) on their accountability of destroying their economy, food supply and millions of individuals and families where food and honor was of no avail

The German 1933 regime achieved the most devastating and murderous antisemitic indoctrination created ever. The hate was indoctrinated and propogated by world-class intellectuals,



scientists, elite, journalists and enlightened thinkers which none of them stopped the Holocaust.

Antisemitism by convenience may also occur when presidents and bureaucrats don't allow the salvation of Jews from massacres or are complicit with the deterioration of Israeli borders and proliferation of weapons and Atomic ordinance to countries like Iran. Those complicit steps are carried out with cover up narratives like the case of the St.Louis.

In June 1939, the German ocean liner St. Louis with 937 passengers, almost all Jewish, were turned away from the port of Miami, forcing the ship to return to Europe which caused many of them to be sent to the crematoriums.

State Department and FBI bureaucrats and President Franklin Roosevelt where more then happy to argue that refugees posed a serious threat to national security.

## **5) Clergical Antisemitism:**

This kind of antisemitism is found when individuals or groups use a religious rhetoric as a justification to oppress, kill or demean Jews using religious rhetoric. An outcome and purpose of religious cancel culturing was increasing of own religion base by overtaxing, oppressing, killing, limiting the transit or converting other religion members using the name of a divine gospel or rhetoric. From the early stages of those new religions the very existence of those religions was dependent on the rate of growth of assimilation and subjugation power. Cancel culture was used to encourage religious conversion or increase the prosperity of followers on expense of the "infidels".

The most common justification for Clergical antisemitism in the early church expansion stage was the "Judas" narrative. This narrative demonizes traditional Jews by alleging that all Jews are supposedly culprits in the capture of Jesus by Romans. It evolved later on to the economy sucking narrative that demonizes Jews for their activity in the lending business by demeaning this kind of business as errant and non compliant with Christian values. They forget to mention that the church and monarchies limited the freedom of Jewish activity on other forms of livelihood. Hence, this CCT vilifies the victims instead of the oppressors. The "usury" hit job was used by Islam as well to oppress or demean Jews.

[4.161] And their taking usury though indeed they were forbidden it and their devouring the property of people falsely, and We have prepared the unbelievers from among them a painful chastisement.

Karl Marx and the Third Reich weaponized this already indoctrinated feeling by portraying "Usuary Jews" as the social class that exploits the working class. If socialism is considered a religion then Karl Marx or his followers may be categorized as Clergical antisemites. In the religion to religion war the existed between Islam and the Church both demeaning the Jews by canceling culturing their way of life and beliefs and blaming them for joining the other religions and for their expulsion from the land.

The "usuary" cancel culture is as old as the clergy writings where jews are depicted as errant communities that deserve moral condemnation.

Clergical attitude to Jews derives from interpretation of the scripts that try to portray Jews as errant or non moral people that don't deserve to be the carriers of the divine gospel. Some

of the inferences are brought from the following verses:

[62.6] Say: O you who are Jews, if you think that you are the favorites of Allah to the exclusion of other people, then invoke death If you are truthful.[2.40] O children of Israel! call to mind My favor which I bestowed on you and be faithful to (your) covenant with Me, I will fulfill (My) covenant with you; and of Me, Me alone, should you be afraid.

[2.47] O children of Israel! call to mind My favor which I bestowed on you and that I made you excel the nations.

[2.62] Surely those who believe, and those who are Jews, and the Christians, and the Sabians, whoever believes in Allah and the Last day and does good, they shall have their reward from their Lord, and there is no fear for them, nor shall they grieve.

[2.83] And when We made a covenant with the children of Israel: You shall not serve any but Allah and (you shall do) good to (your) parents, and to the near of kin and to the orphans and the needy, and you shall speak to men good words and keep up prayer and pay the poor-rate. Then you turned back except a few of you and (now too) you turn aside.

[2.88] And they say: Our hearts are covered. Nay, Allah has cursed them on account of their unbelief; so little it is that they believe.

[2.98] Whoever is the enemy of Allah and His angels and His apostles and Jibreel and Meekaeel, so surely Allah is the enemy of the unbelievers.

[2.111] And they say: None shall enter the garden (or paradise) except he who is a Jew or a Christian. These are their vain desires. Say: Bring your proof if you are truthful.

[2.113] And the Jews say: The Christians do not follow anything (good) and the Christians say: The Jews do not follow anything (good) while they recite the (same) Book. Even thus say those who have no knowledge, like to what they say; so Allah shall judge between them on the day of resurrection in what they differ.

[2.120] And the Jews will not be pleased with you, nor the Christians until you follow their religion. Say: Surely Allah's guidance, that is the (true) guidance. And if you follow their desires after the knowledge that has come to you, you shall have no guardian from Allah, nor any helper.

[2.121] Those to whom We have given the Book read it as it ought to be read. These believe in it; and whoever disbelieves in it, these it is that are the losers.

[2.122] O children of Israel, call to mind My favor which I bestowed on you and that I made you excel the nations.

[2.135] And they say: Be Jews or Christians, you will be on the right course. Say: Nay! (we follow) the religion of Ibrahim, the Hanif, and he was not one of the polytheists.

[2.140] Nay! do you say that Ibrahim and Ismail and Yaqoub and the tribes were Jews or Christians? Say: Are you better knowing or Allah? And who is more unjust than he who conceals a testimony that he has from Allah? And Allah is not at all heedless of what you do.

[2.211] Ask the Israelites how many a clear sign have We given them; and whoever changes the favor of Allah after it has come to him, then surely Allah is severe in requiting (evil).

[2.246] Have you not considered the chiefs of the children of Israel after Musa, when they said to a prophet of theirs: Raise up for us a king, (that) we may fight in the way of Allah. He said: May it not be that you would not fight if fighting is ordained for you? They said: And what reason have we that we should not fight in the way of Allah, and we have indeed been compelled to abandon our homes and our children. But when fighting was ordained for them, they turned back, except a few of them, and Allah knows the unjust.

### The Family of Imran

[3.23] Have you not considered those (Jews) who are given a portion of the Book? They are invited to the Book of Allah that it might decide between them, then a part of them turn back and they withdraw.

[3.24] This is because they say: The fire shall not touch us but for a few days; and what they have forged deceives them in the matter of their religion.

[3.49] And (make him) an apostle to the children of Israel: That I have come to you with a sign from your Lord, that I determine for you out of dust like the form of a bird, then I breathe into it and it becomes a bird with Allah's permission and I heal the blind and the leprous, and bring the dead to life with Allah's permission and I inform you of what you should eat and what you should store in your houses; most surely there is a sign in this for you, if you are believers.

[3.67] Ibrahim was not a Jew nor a Christian but he was (an) upright (man), a Muslim, and he was not one of the polytheists.

[3.93] All food was lawful to the children of Israel except that which Israel had forbidden to himself, before the Taurat was revealed. Say: Bring then the Taurat and read it, if you are truthful.

### The Women

[4.46] Of those who are Jews (there are those who) alter words from their places and say: We have heard and we disobey and: Hear, may you not be made to hear! and: Raina, distorting (the word) with their tongues and taunting about religion; and if they had said (instead): We have heard and we obey, and hearken, and unzurna it would have been better for them and more upright; but Allah has cursed them on account of their unbelief, so they do not believe but a little.

[4.47] O you who have been given the Book! believe that which We have revealed, verifying what you have, before We alter faces then turn them on their backs, or curse them as We cursed the violaters of the Sabbath, and the command of Allah shall be executed.

[4.50] See how they forge the lie against Allah, and this is sufficient as a manifest sin.

[4.160] Wherefore for the iniquity of those who are Jews did We disallow to them the good things which had been made lawful for them and for their hindering many (people) from Allah's way.

[4.161] And their taking usury though indeed they were forbidden it and their devouring the property of people falsely, and We have prepared for the unbelievers from among them a painful chastisement.

### The Dinner Table

[5.12] And certainly Allah made a covenant with the children of Israel, and We raised up among them twelve chieftains; and Allah said: Surely I am with you; if you keep up prayer and pay the poor-rate and believe in My apostles and assist them and offer to Allah a goodly gift, I will most certainly cover your evil deeds, and I will most certainly cause you to enter into gardens beneath which rivers flow, but whoever disbelieves from among you after that, he indeed shall lose the right way.

[5.13] But on account of their breaking their covenant We cursed them and made their hearts hard; they altered the words from their places and they neglected a portion of what they were reminded of; and you shall always discover treachery in them excepting a few of them; so pardon them and turn away; surely Allah loves those who do good (to others).

[5.18] And the Jews and the Christians say: We are the sons of Allah and His beloved ones. Say: Why does He then chastise you for your faults? Nay, you are mortals from among those whom He has created, He forgives whom He pleases and chastises whom He pleases; and Allah's is the kingdom of the heavens and the earth and what is between them, and to Him is the eventual coming.

[5.32] For this reason did We prescribe to the children of Israel that whoever slays a soul, unless it be for manslaughter or for mischief in the land, it is as though he slew all men; and



whoever keeps it alive, it is as though he kept alive all men; and certainly Our apostles came to them with clear arguments, but even after that many of them certainly act extravagantly in the land.

[5.33] The punishment of those who wage war against Allah and His apostle and strive to make mischief in the land is only this, that they should be murdered or crucified or their hands and their feet should be cut off on opposite sides or they should be imprisoned; this shall be as a disgrace for them in this world, and in the hereafter they shall have a grievous chastisement,

[5.41] O Apostle! let not those grieve you who strive together in hastening to unbelief from among those who say with their mouths: We believe, and their hearts do not believe, and from among those who are Jews; they are listeners for the sake of a lie, listeners for another people who have not come to you; they alter the words from their places, saying: If you are given this, take it, and if you are not given this, be cautious; and as for him whose temptation Allah desires, you cannot control anything for him with Allah. Those are they for whom Allah does not desire that He should purify their hearts; they shall have disgrace in this world, and they shall have a grievous chastisement in the hereafter.

[5.42] (They are) listeners of a lie, devourers of what is forbidden; therefore if they come to you, judge between them or turn aside from them, and if you turn aside from them, they shall not harm you in any way; and if you judge, judge between them with equity; surely Allah loves those who judge equitably.

[5.43] And how do they make you a judge and they have the

Taurat wherein is Allah's judgment? Yet they turn back after that, and these are not the believers.

[5.44] Surely We revealed the Taurat in which was guidance and light; with it the prophets who submitted themselves (to Allah) judged (matters) for those who were Jews, and the masters of Divine knowledge and the doctors, because they were required to guard (part) of the Book of Allah, and they were witnesses thereof; therefore fear not the people and fear Me, and do not take a small price for My communications; and whoever did not judge by what Allah revealed, those are they that are the unbelievers.

[5.51] O you who believe! do not take the Jews and the Christians for friends; they are friends of each other; and whoever amongst you takes them for a friend, then surely he is one of them; surely Allah does not guide the unjust people.

[5:57] O you who believe! do not take for guardians those who take your religion for a mockery and a joke, from among those who were given the Book before you and the unbelievers; and be careful of (your duty to) Allah if you are believers.

[5.59] Say: O followers of the Book! do you find fault with us (for aught) except that we believe in Allah and in what has been revealed to us and what was revealed before, and that most of you are transgressors?

[5.60] Say: Shall I inform you of (him who is) worse than this in retribution from Allah? (Worse is he) whom Allah has cursed and brought His wrath upon, and of whom He made apes and swine, and he who served the Shaitan; these are worse in place and more erring from the straight path.

[5.63] Why do not the learned men [rabbis] and the doctors of law prohibit them from their speaking of what is sinful and their eating of what is unlawfully acquired? Certainly evil is that which they work.

[5.64] And the Jews say: The hand of Allah is tied up! Their hands shall be shackled and they shall be cursed for what they say. Nay, both His hands are spread out, He expends as He pleases; and what has been revealed to you from your Lord will certainly make many of them increase in inordinacy and unbelief; and We have put enmity and hatred among them till the day of resurrection; whenever they kindle a fire for war Allah puts it out, and they strive to make mischief in the land; and Allah does not love the mischief-makers.

[5.69] Surely those who believe and those who are Jews and the Sabians and the Christians whoever believes in Allah and the last day and does good-- they shall have no fear nor shall they grieve.

[5.70] Certainly We made a covenant with the children of Israel and We sent to them apostles; whenever there came to them an apostle with what that their souls did not desire, some (of them) did they call liars and some they slew.

[5.72] Certainly they disbelieve who say: Surely Allah, He is the Messiah, son of Marium; and the Messiah said: O Children of Israel! serve Allah, my Lord and your Lord. Surely whoever associates (others) with Allah, then Allah has forbidden to him the garden, and his abode is the fire; and there shall be no helpers for the unjust.

[5.73] Certainly they disbelieve who say: Surely Allah is the third (person) of the three; and there is no god but the one God, and if they desist not from what they say, a painful chastisement shall befall those among them who disbelieve.

[5.78] Those who disbelieved from among the children of Israel were cursed by the tongue of Dawood and Isa, son of Marium; this was because they disobeyed and used to exceed the limit.

[5.79] They used not to forbid each other the hateful things (which) they did; certainly evil was that which they did.

[5.80] You will see many of them befriending those who disbelieve; certainly evil is that which their souls have sent before for them, that Allah became displeased with them and in chastisement shall they abide.

[5.81] And had they believed in Allah and the prophet and what was revealed to him, they would not have taken them for friends but! most of them are transgressors.

[5.82] Certainly you will find the most violent of people in enmity for those who believe (to be) the Jews and those who are polytheists, and you will certainly find the nearest in friendship to those who believe (to be) those who say: We are Christians; this is because there are priests and monks among them and because they do not behave proudly.

[5.86] And (as for) those who disbelieve and reject Our communications, these are the companions of the flame.

[5.110] When Allah will say: O Isa son of Marium! Remember My favor on you and on your mother, when I strengthened you

I with the holy Spirit, you spoke to the people in the cradle and I when of old age, and when I taught you the Book and the wisdom and the Taurat and the Injeel; and when you determined out of clay a thing like the form of a bird by My permission, then you breathed into it and it became a bird by My permission, and you healed the blind and the leprous by My permission; and when you brought forth the dead by My permission; and when I withheld the children of Israel from you when you came to them with clear arguments, but those who disbelieved among them said: This is nothing but clear enchantment.

### The Cattle

[6.146] And to those who were Jews We made unlawful every animal having claws, and of oxen and sheep We made unlawful to them the fat of both, except such as was on their backs or the entrails or what was mixed with bones: this was a punishment We gave them on account of their rebellion, and We are surely Truthful.

### The Elevated Places

[7.105] (I am) worthy of not saying anything about Allah except the truth: I have come to you indeed with clear proof from your Lord, therefore send with me the children of Israel.

[7.134] And when the plague fell upon them, they said: O Musa! pray for us to your Lord as He has promised with you, if you remove the plague from us, we will certainly believe in you and we will certainly send away with you the children of Israel.

[7.137] And We made the people who were deemed weak to inherit the eastern lands and the western ones which We had blessed; and the good word of your Lord was fulfilled in the

children of Israel because they bore up (sufferings) patiently; and We utterly destroyed what Firon and his people had wrought and what they built.

[7.138] And We made the children of Israel to pass the sea; then they came upon a people who kept to the worship of their idols. They said: O Musa! make for us a god as they have (their) gods. He said: Surely you are a people acting ignorantly:

### The Immunity

[9.30] And the Jews say: Uzair is the son of Allah; and the Christians say: The Messiah is the son of Allah; these are the words of their mouths; they imitate the saying of those who disbelieved before; may Allah destroy them; how they are turned away!

[9:34] O you who believe! most surely many of the doctors of law [rabbis] and the monks eat away the property of men falsely, and turn (them) from Allah's way; and (as for) those who hoard up gold and silver and do not spend it in Allah's way, announce to them a painful chastisement....

### Jonah

[10.90] And We made the children of Israel to pass through the sea, then Firon and his hosts followed them for oppression and tyranny; until when drowning overtook him, he said: I believe that there is no god but He in Whom the children of Israel believe and I am of those who submit.

[10.93] And certainly We lodged the children of Israel in a goodly abode and We provided them with good things; but they did not disagree until the knowledge had come to them; surely your Lord will judge between them on the resurrection

day concerning that in which they disagreed.

### The Bee

[16.118] And for those who were Jews We prohibited what We have related to you already, and We did them no injustice, but they were unjust to themselves.

### The Children of Israel

[17.2] And We gave Musa the Book and made it a guidance to the children of Israel, saying: Do not take a protector besides Me;

[17.4] And We had made known to the children of Israel in the Book: Most certainly you will make mischief in the land twice, and most certainly you will behave insolently with great insolence.

[17.101] And certainly We gave Musa nine clear signs; so ask the children of Israel. When he came to them, Firon said to him: Most surely I deem you, O Musa, to be a man deprived of reason.

[17.104] And We said to the Israelites after him: Dwell in the land: and when the promise of the next life shall come to pass, we will bring you both together in judgment.

### Marium

[19.58] These are they on whom Allah bestowed favors, from among the prophets of the seed of Adam, and of those whom We carried with Nuh, and of the seed of Ibrahim and Israel, and of those whom We guided and chose; when the communications of the Beneficent God were recited to them, they fell down making obeisance and weeping.

Ta Ha

[20.47] So go you both to him and say: Surely we are two apostles of your Lord; therefore send the children of Israel with us and do not torment them! Indeed we have brought to you a communication from your Lord, and peace is on him who follows the guidance;

[20.48] Surely it has been revealed to us that the chastisement will surely come upon him who rejects and turns back.

[20.80] O children of Israel! indeed We delivered you from your enemy, and We made a covenant with you on the blessed side of the mountain, and We sent to you the manna and the quails.

[20.94] He said: O son of my mother! seize me not by my beard nor by my head; surely I was afraid lest you should say: You have caused a division among the children of Israel and not waited for my word.

[22.17] Surely those who believe and those who are Jews and the Sabeans and the Christians and the Magians and those who associate (others with Allah)-- surely Allah will decide between them on the day of resurrection; surely Allah is a witness over all things.

[22.40] Those who have been expelled from their homes without a just cause except that they say: Our Lord is Allah. And had there not been Allah's repelling some people by others, certainly there would have been pulled down cloisters and churches and synagogues and mosques in which Allah's name is much remembered; and surely Allah will help him who helps



His cause; most surely Allah is Strong, Mighty.

[26.17] Then send with us the children of Israel.

[26.22] And is it a favor of which you remind me that you have enslaved the children of Israel?

[26.59] Even so. And We gave them as a heritage to the children of Israel.

[26.197] Is it not a sign to them that the learned men of the Israelites know it?

#### The Ant

[27.76] Surely this Quran declares to the children of Israel most of what they differ in.

#### The Adoration

[32.23] And certainly We gave the Book to Musa, so be not in doubt concerning the receiving of it, and We made it a guide for the children of Israel.

#### The Believer

[40.53] And certainly We gave Musa the guidance, and We made the children of Israel inherit the Book,

#### Ornaments of Gold

[43.59] He was naught but a servant on whom We bestowed favor, and We made him an example for the children of Israel.

#### The Smoke

[44.30] And certainly We delivered the children of Israel from

the abasing chastisement,

### The Kneeling

[45.16] And certainly We gave the Book and the wisdom and the prophecy to the children of Israel, and We gave them of the goodly things, and We made them excel the nations.

### The Sandhills

[46.10] Say: Have you considered if it is from Allah, and you disbelieve in it, and a witness from among the children of Israel has borne witness of one like it, so he believed, while you are big with pride; surely Allah does not guide the unjust people.

### The Banishment

[59.2] He it is Who caused those who disbelieved of the followers of the Book to go forth from their homes at the first banishment you did not think that they would go forth, while they were certain that their fortresses would defend them against Allah; but Allah came to them whence they did not expect, and cast terror into their hearts; they demolished their houses with their own hands and the hands of the believers; therefore take a lesson, O you who have eyes!

[59.3] And had it not been that Allah had decreed for them the exile, He would certainly have punished them in this world, and in the hereafter they shall have chastisement of the fire.

### The Ranks

[61.6] And when Isa son of Marium said: O children of Israel! surely I am the apostle of Allah to you, verifying that which is before me of the Taurat and giving the good news of an Apostle who will come after me, his name being Ahmad, but when he came to them with clear arguments they said: This is

[61.7] And who is more unjust than he who forges a lie against Allah and he is invited to Islam, and Allah does not guide the unjust people.

[61.14] O you who believe! be helpers (in the cause) of Allah, as~ Isa son of Marium said to (his) disciples: Who are my helpers in the cause of Allah? The disciples said: We are helpers (in the cause) of Allah. So a party of the children of Israel believed and another party disbelieved; then We aided those who believed against their enemy, and they became uppermost.

[62.6] Say: O you who are Jews, if you think that you are the favorites of Allah to the exclusion of other people, then invoke death If you are truthful.

## **Socialism and Antisemitism**

Carl Marx elaborated on the cycle of the social class displacements, but "forgot" to mention that if and when the socialist class raises to power it becomes the self indulgent class that destroys the working class state with corruption until another class takes power. For that reason the idea of perpetual Utopia is a fake gospel that contradicts the human condition that humans have desire to exploit other humans and a primordial need to survive while increasing self indulgences and honor.

To some extent, Marks, Hagel, Bernie Sander and Engels used tribalism for making "capitalist" money by exploiting the working class selling books that would make them believe that they wouldn't be exploited by socialist movement, trade unions and soviets. # Intrasemitism

## Premise

For the purpose of analyzing the evolution and characteristics of Cancel Culture Tribalism, we can take a look at the most contiguous form in history of cancel culture, namely the targeting of communities that observe Judaism. By Judaism herein, we refer to the Jewish religious practitioners that follow the orthodox interpretation of the bible as opposed to the reformist, Cristian and conservative interpretation. Jewish orthodox communities have suffered persecution and livelihood oppression both from the hands of secular jews (intrasemitism) and non-jews (antisemitism) for similar and different reasons. Hence, Jews and non Jews alike that demean orthodox Jews, may be considered as cancel culture tribalists and can be categorized as suffering from Anti Judaism Derangement Syndrome (JDS) or Orthodoxophobia. Orthodoxophobia is a specific manifestation of antisemitism and intrasemitism, which encompasses the hate of orthodox Jews by socialist, woke or progressive secular Jews which have xenophobic feelings over religious rituals and dress-code. Intrasemitism is the delegitimization of those communities or individuals that don't deligitimize those communities. Hence, intrasementism may occur when reformist or progressive secular Jews target other secular Jews.

Most notable in the political Israeli arena for 75 years is the cancel culture campaign of political party prominent members and journalists within the Labor party, Meretz and Yesh Atid. Those members conduct conceptual persecution on the Likud Party leaders or traditional Seferadic jews by weaponizing

media and judicial hit jobs for the sake of gaslighting their stronghold in military top brass, judicial system, trade unions, monopolies and companies that win government bids. They use a cancel culture campaign or JDS blaming the Likud party for funding basic orthodox needs of communities and blaming them for not serving in the army or not supporting Socialism, Sodom-ism or Environment Social Governance.

Secular to Secular Intrasemitism in Israel, backdates to the 1930s when Socialist Jews and the Progressive media colluded with the British Government against Revisionist members (non socialist Secular Jews) and caused apprehensions, deportations, livelihood restrains, the massacre of "Altalena" and some say even executions. Secular to Secular intrasemitism materialized in Europe during the holocaust between Socialist Jewish parties as can be inferred from the Kastner affair, Joel Brand detention and the delegitimization made by socialist parties on Beitar members during the Warsaw Ghetto uprising.

## Faith and Civility

Any combination of civility values and religious observance may help us understand individual or community values and their consequential social interactions. Accordingly with tradition, the Jewish community is composed on four major sub-classes of individuals depending on their behavioral values. This is the interpretation of the "Four species" ritual that conveys the concept that "Israel society" is made up by four sub-classes in a similar way as nature. There are specimens with scent and flavor (like the Etrog/ citron) and there are specimens with all other combinations thereof. In Judaism the scent may represent civility whereas the flavor may represent the faith as it materializes through orthodox religion. This sub-categorization can be projected to any kind of societies.

Accordingly to the "Four Specimens" analogy in Judaism, we can find any permutation of civility and faith predominant values. If we assume that Judaism is defined by orthodox tradition, the disputed topic is who defines and enforces civility. Judaism accommodates civility in the diaspora or under occupation, by addressing Governance laws as laws of the land that should be obeyed whenever those laws don't destroy Judaism.

Such was the case in the conflicts between the Hellenic Jews and the Maccabees and the civil war in the big revolt during the Roman occupation. As defined before, reformist Judaism and Jewish Hellenism is way of destroying traditional Judaism by assimilating Jews by using controversial pick and chose from the holy scripts and injecting biased interpretation of civility



into a more lenient or "trendy" religion.

Civility is the mechanism that allows community members to prosper and coexist with each other by way of showing courtesy and creating just laws while applying the law equally. The United States is a "post civility" society because the laws are not applied equally since it enables lawmakers to use privileged information to enrich themselves (like buying and selling stocks), the president friends and family, bureaucrats and government contractors engage in influence padding and trade unions within government and industries appoint their friends and family to critical positions.

Civility is addressed within the Judaism as the way of the land (Derech Eretz) whereas the religion in Judaism is defined by written commandments and specific rules that ensure the fulfillment of those commandments. Quoting the scripts by the same token, "Civility precedes religion". The meaning of "precedes" may be disputed on whether it refers to be chronological or preferential order. Anyway, civility by itself may be interpreted in a self destructive way like in Sodom, Rome, the French Revolution, the October revolution and the United States border policy before the Mexican-American war that brought the civil war and during the Biden administration.

For that matter, there are individuals that their prominent values rely on religion and civility. There are individuals that accentuate religion over civility. There are individuals and communities that their prominent values rely solely on their interpretation of civility where some of them interpret civility as a cancel culture that deligitimizes traditional religion like orthodoxophobs or prominent supreme court judges and journalists in Israel.

Those individuals may feel contempt to religious communities and justify that attitude by portraying civility as a mechanism that tarnishes religious individuals that don't abide to their woke definition of civility. Mainstream media journalists and academy members may be promoted if they engage in anti orthodox hate speech that is disguised with media or judicial hit jobs.

For the sake of this analysis we confine the definition of Intrasementims to the cancel culture between Jews where the cancelculturing community disapproves or despises the targeted community or individuals that is whitewashed with laundered intellectual, progressive or socialist rhetoric.

Basically, the Jewish reformist religion was created by injecting virtual signaling or progressive values in the interpretation of the bible and picking some convenient commandments and ignoring others or making contradictory interpretations. The movements was and is followed for the purpose of demeaning the traditional rituals and/or for being cherished and protected by gentile communities.

Although reformist movements are in the open for 200 years, the methodology of injecting new values into the bible took place for three millennia and grew after the first translation of the bible in Alexandria about 2400 years ago. The translation enabled, a non traditional pick and choose commandments of the holy scripts by new religions or by "new" Jews. This "tainting" process was already implemented by the Jewish Sadducees movement, Hellenist Jews, and some say by Samaritans, Cristian and Muslim scholars.

Ortodoxophobia is propagated in Israeli TV with media hit jobs that tarnish orthodox communities. It can be seen in billboards in Tel Aviv, progressist and socialist newspapers, army top brass discourse, ONGs, elections, Knesset and the justice system. Astonishingly, the tarnishing methodology and discourse are similar with Der Sturmer, Carl Marx, the protocol of the elders of Zion, Martin Luther writings which all try to portray Orthodox Jews as "leachers" of the community either for their trade, location, their appearance or rituals.

Since 1967, Intrasemetism expanded itself to include cancel culture tribalism that demonizes orthodox Jews that live in Judea what is referred to as Judeaphobia. Paradoxically, the socialist parties which embrace Judeaphobic discourse, are the parties that sent orthodox Jews to live in Judeam Sanaria and Gaza by their leaders including Moshe Dayan and Shimon Peres. The latter founded Sebastia's and even was part of the corner stone ceremony which was one of the first events of Jews returning to their land after the 1929 and 1948 pogroms and ethnic cleansing. Peres and his associates weaponized a Cancel culture entrapment campaign to demonize the settler Jews later on. Judeaphobes ignore the fact that Muslim pogroms and ethnic cleansing were conducted in Judea in complicity of the British mandate and other western countries for 100 years in Judea.

Most prominent was the 1929 pogrom in Hebron and the Jordanian army ethnic cleansing in Jerusalem and Gush Etzion circa 1948 as well as the bombing of the Ben Yehuda street in Jerusalem by British soldiers that caused the killing of 58 civilians. The 1929 pogrom was the cornerstone of the New Jihadist holy land terror movement because it convinced Britain and later on the United Nations to pander to ethnic

cleansing terrorism by submitting themselves to the rethoric that the Muslims have more title on Hebron then Christians or Jews. This pandering is what causes the ethnic cleaning of Christian form Bethlehem, Jerusalem, Lebanon and other Muslim countries.

Eventhough Intrasementism may be attributed to secular hate of orthodox Jews, it may occur as well between secular Jews as well. Such is the case when a group of woke jews target secular jews that don't embrace their cancel culture narratives. Most likely secular to secular intrasemitism would occur when a secular Jew demeans and despises Jews that respect orthodoxy, or a Jew that don't adhere to socialism, progressism, environmental social governance (ESG), LBGQTQAI+ discourse, mandatory vaccinations or a Jew that opposes judicial activism, or an Israeli that question the professionalism and double standards of the army, historians and the judicial system and so on. Since 1967 orthodoxphobia increased the cancel culture discourse by enhancing their bank of targets creating more smear campaigns against orthodox jews that live in Judea and Samaria.

Secular to Secular Intrasemitism in Israel, backdates to the 1930s when Socialist Jews and the Progressive media colluded with the British Government against Revisionist members (non socialist Secular Jews) and caused apprehensions, deportations, the massacre of "Altalena" and some say even death sentences. Secular to Secular intrasemitism materialized in Europe during the holocaust between Socialist Jewish parties as can be inferred from the Kastner affair, Joel Brand detention and the delegitimization made by socialist parties on Beitar

members during the Warsaw Ghetto uprising.

The attitude of orthodox and revisionist Jews to progressive Jews is not classified as intrasemitism because they don't feel contempt or delegitimize the very existence of the others in the Holy Land.

## **Intrasemitic Double Downing**

Anti orthodox Intrasemitism comes along with hate and contempt of jews that respect or live by the orthodox interpretation of the bible. In many cases it is propagated with smear campaigns that come masked with progressive discourse, moral highground narratives and scholar or media hit jobs. The traditional orthodox intrasemitism has main three characteristics and origins that can complement or replace each other. This permutation may include any combination of xenophobia, leachophobia or progressive intrasemitism as explained later on. When an Intrasemitism individual finds a dissonance or is being targeted in a pogrom or antisemitism he might double down on his rhetoric using the other indoctrinations.

An Orthodoxophobic dissonance may occur when a family member or co-worker is found to be orthodox or when being targeted by a terrorist attack. In those cases the subject may realize that orthodox or non woke jews are humans and can be benevolent and that accumulated hate, patronizing or contempt may have been unjustified. Such a case may happen in terror attacks where the terrorist doesn't care who is the target as well.

In many cases the orthodoxophob will double down and increase the contempt or hate by blaming the the orthodox victim or community as being the reason for his victimhood and alleging that his demise was caused by the very "existence: of the orthodox jew. It is estimated that 20% of the secular Israeli population believes that the Revisionist and orthodox jews pose more threat to their lives than the terror

organizations because of media, military and scholar brainwash that is funded by American state department actors and Israeli woke ONGs. Such is the case of retired failed IDF generals that blame the orthodox Jews that live in Judea, for the October 7th massacres near Gaza, because they were the the masterminds of the Oslo plan of arming terrorists and evacuating Jews from Gaza, and enabled the transfer of rockets through Egyptian tunnels, which caused the massacre. Anti secular intrasemitism is derived from the anti orthodox intrasemitism because the targets of hate are the people who don't hate orthodox jews or don't share progressive ideas.

The origins and forms of intrasemitism may have anti orthodox or non religious ingredients and are described as follows:

## 1) Progressive Assimilation

Progressive assimilation is the process in which communities buy into new romanticized or trendy ideologies that ignore, defy or distort traditional Judaism. It was observed within the Hellenistic movement after Alexander the great conquests in the middle east and was the major agent of Jewish civil wars thereafter, be it during the Hellenic, Roman or the Altalena massacre. The major agent during the last 200 years of Intrasemitism was the adaptation of Socialism and Jewish Reformism which today are replaced by progressive social justice cancel culture that the Democrat party disseminates today in the United States and elsewhere which targets Jewish and Christian communities and turns a blind eyes to Islam communities or colleges that endorse killing Jews by way of allowing free speech which is genocidal hate speech.

Progressive Assimilation can be observed when a radical left Jew is blaming another Jew as being "Fascist" or "Mesiasic" which is another way of saying "babaric orthodox". The "mesiasic" pejorative is a racist expression because it allude to portraying a Jew that believes in the Messiah is not legitim as a Muslim or Cristian that believe in the Messiah or prophet. This term is used to undermine the justification of Jews rights in Judea because of their believe in the Holy scripts that Jerusalem, Hebron and other cities were properties of the Jewish people before Islam.

Antirevisionism is the kind of secular to secular intrasemetism and contempt that woke, socialist and progressive jews hold against jews that don't buy into their ideologies. This kind of intrasemitism was found in the writings of socialist and



progressive scholars and journalists like Arlozorov and Berl Katznelson since the 1920s. Revisionist Jews were cancelled by alleging that revisionists have low moralities and are violent or "fascists". This, in fact, is the same *modus operandi* used by far left organizations and mainstream media today in the United States and in Europe.

The smear campaigns succeeded in achieving progressive hegemony because socialists and progressives controlled the media, academy and the trade unions and were the main contractors of the British authorities within the mandate. Some accounts even suggest that both colluded and interchanged smear campaigns that led to the apprehension and execution of revisionist Jews. The persecution of revisionist Jews made up by and collaboration of socialist Jews with English authorities was referred to as "Saison de Chasse".

Revisionism was a movement conceived by Jabotinsky in the 1920s, that believed in the creation of a Jewish state with libertarian values as opposed to socialist and anti-orthodox values. Paradoxically, most Israelis vote against socialism and wokeism, but they cannot exert their power in government because decision-making positions in bureaucracy as well as monopoly organizations such as the energy and communication monopolies are controlled by the elite that holds progressive and socialist ideology.

Anti-revisionist ideology was adopted by Ben-Gurion's Histadrut trade union and Jewish Agency (Sohnut), the socialist army (Haganah) and since the 1920s all the way until today. In 2023, the elected government tried to change the monolithic undemocratic appointing mechanisms to be more diversified, but the media, the justice system and the army blocked this

attempt creating chaos and posing military threats to the government, which eventually, some argue, invited the October 7th massacres.

The Israeli mainstream media and promoted generals embrace intrasemitism against the Likud party members by trying to depict them as "fascists" for not supporting ideas such as judicial woke activism. This kind of intrasemitism is doubledowning on their smear campaigns whenever their appointed agents corruptive behavior's is exposed or an orthodoxophob is about to be removed from the judicial system, academy or military.

Their double standards was exposed when they supported Supreme Court judges that appoint their families and ortodoxophobs while restricting the appointment of Sefaradi or orthodox judges. The same modus operandi can be seen in the process of conducting military promotions of orthodoxophobs or woke generals or appointing them as directors in monopolies or government contractors for that reason as well. The same preferential promotion mechanism is used within bureaucracy where a decision maker appointment process is controlled by bureaucracy trade unions and the Attorney general cohorts and the Legal advisor to the government office.

The most powerful institution in Israel is the not elected position of the government legal advisor that can filter out any non woke appointment with the collusion of the supreme court and media. Thus, Israel is not a true democracy, rather an Elitocracy where favoritism and wokeism decide who is appointed and what policies should be carried out.

Those bureaucrats protect each other and interchange appointments with the supreme court and other legislative entities. Since the 1948 these offices were run by Orthodoxophobes or Antirevisionist even after 1977 when the socialist parties lost the elections. This is because the appointment mechanism is not controlled by the elected parties and the def facto "deep state" already grasped the control of these institutions. The judicial bureaucracy has the mechanism of filtering out any candidate who may risk their using can of worms either fabricated or double standardized using their agents or family members in the media or security forces.

The use of this modus operandi has similar terminology and depiction to what some Democrat party members and their think tanks are using against conservatives using the media, their cohorts in the judicial system and government (specially the counterintelligence community) and in congress. The modus operandi is exposed whenever the supreme court stalls an appointment of non woke official after a preferential court filing made a woke ONG like the movement for quality of government injunction motion against non woke prospects.

## **2) Lucrative Intrasemitism**

Lucrative intrasemitism may be generated from a survivability event or "Influence Peddling" event. When a Lucrative intrasemitism is combined with another form of intrasemitism it has a multiplier effect such as receiving high score in academic paper, bidding to conduct a media hit job poll or advertising campaign or winning a contractor bid for the government or army.

in this process secular jews cooperate in the process of CCT against orthodox and libertarian jews for the sake of their own advancement, enrichment or survivability. Supposedly, collaboration with antisemites through snitching and helping Jew or orthodox persecution of would enable their survival or even help to their enrichment or appointment in bureaucracy.

In hindsight, Survivability intrasemitism brought disaster on all jews both in the holocaust and in October 7th massacre. The struggle to blend with socialism, progressivism, anticolonialism by tarnishing orthodox way of life brought exactly the opposite. Socialists that tried to appease antisemitism by condemning orthodoxy and snitching against their brothers were used by genocide groups to divide and conquer bringing all kind of jews to crematoriums, rape and murder.

### **3) Leechophobia**

The argumentation of Leechophobia intrasemitism would be that Orthodox Jews allegedly are counterproductive to civility, prosperity, socialism, public health, progressivism or national security and that they engage in violence when they try to defend themselves. Leechophobia has similar rhetoric than the "Elders of Zion conspiracy theory" that portrays Jews as "body that leeches society" preceded by smear campaigns in curricula and by judicial and media hit jobs that have xenophobic feeling, political opportunism or lucrative incentives.

Leechophobia is used within socialist and progressive parties and Israeli orthodoxophobic editorials. This kind of orthodoxophobia is perpetuated by the Israel broadcast authority on Sabbath news reporting and op-eds when orthodox people can't react. It was maliciously propagated using media hit jobs like using vilifying cameras cuts on Sabbath protests against car driving in orthodox communities or by putting offensive advertisements of un-puritan dress code in orthodox communities and media and not doing the same in Muslim communities.

It may occur also because of a vendetta of a decision maker. At the outset of Israel creation Haim Cohn had a vendetta with orthodoxy, some attribute it to not being allowed to have a Jewish marital status with a divorced woman because priesthood descendants are not allowed to marry in such cases. Cohn was one of the founders of Judicial activism movement which puts progressive interpretation of the law in a mode that nullifies Jewish religion commandments while

respecting Muslim commandments. Cohn was the mentor of Aharon Barak who was complicit with the civil unrest in 2023 and the army revolt against the parliament. Both were Israel Attorney generals and later on supreme court judges which their ruling and appointments were compromised by their beliefs in a manner that the appointment of religious or Sefaradi Judges was very limited for almost 80 years.

Today everyone can avoid being drafted with psychological excuses, but Orthodox Jews can't use psychological religious shock as an excuse and therefore they are not allowed to be part of the workforce by law. Antirevisionist family members have higher chances of being "drafted" to elitist units that promise civilian jobs or influence peddling opportunities (like the airforce, intelligence or computing and high tech units) or promoted to high pension positions in the army. In some cases sons of general staff officers participate in high tech managements or IPOs leveraging a technological know-how acquired during their family military service.

Beni Gantz who was a former army chief of staff and political enemy of Likud, served as a director in "5th Dimension" company that conducted allegedly non bidding or illegal sales operations of spyware to the police and Qatar (which funds and gives aid and comfort to Hamas). Beni Gantz was appointed by another former chief of stuff Ehud Barak who "coincidentally" was also staunch enemy of the Likud and "coincidentally" is also running an international military commerce outfit using influence peddlers like Jeffry Epstein. Most former chief of staffs and former intelligence top officials are political enemies of the Likud and use anti orthodox rhetoric by posing as "Democracy" gatekeepers".

In retrospect several cases of intrasemitic media hit jobs are a coverups that use Leechophobia to gaslight influence peddling made by orthodoxophobs or antirevisionists which are a classical projection of self misconduct on others. Leachophobs use classic antisemite methods that weaponize the "unbearable lightness" of smear campaigns that weaponize existing orthodox hate that is derived from an easy targeting, detection, confinement, appearance and rituals. The use of provocateurs or entrappers by the intelligence community or media is emblematic for creating a media smear campaigns that tries to promote leechophbia which has an outcome of smearing or delegitimizing entire communities.

Male orthodox jews are not allowed to work in Israel because of a law that denies livelihood freedoms for observing jews if they don't serve in the army. This law is racist because it doesn't apply to other religions or Arabs. This law was created by Ben Gurion associates from the socialist parties in order to tarnish orthodox reputation, restrict their income and force them to assimilate. The law was justified by the media and justice system through a narrative that tries to portray them as "leachers", even knowing that he army can't provide a puritan environment and that a forced conscription would entail abuse of freedom of religion and a violence against conscious awareness. For the sake of comparison Congress wouldn't enact a law that would deny working opportunities from the Amish community for not participating in the army.

Observant Orthodox people are reluctant from serving in the army because the army doesn't provide puritan environment, real Kosher food and conditions that enable Sabbath observance. This is evidenced by the IDF porcupine cooking incident and the fact that Secular commanders are able to

enforce Sabbath violations on orthodox soldiers with pretexts that they see fit. The evidence that it was a sinister law made up by the socialist parties, is the fact the at top brass of the army expressed their objection of massive conscripting orthodox jews because of their own fear against a potential religiousinisation of the army. Another evidence would be that other types of conscious exemption form army duties are allowed by double standard judges and army human resources bureaucrats that came from anti orthodox academies.

This law was created by Ben Gurion associates in the justice department and Knesset as part of a shaming campaign and religion cleansing effort made by the socialist parties in Israel. in those times socialist secular jews were abducting children from Yemenite and Iraqi orthodox Jewish migrants in order to indoctrinate children and increase the secular jews community on expense of the observer community. Consequently, Orthodox jews live under a livelihood terror regime in Israel. They are not promoted to a decision making positions in the army, judiciary, academy and government bureaucracy unless they comply with secular agenda of protecting the secular progressive apparatus or serve as fig leaves of progressive cancel culture. In this context Intrasemetism refers to Secular jews that disqualify, delegitimize Jews in a cancel culture state of mind that the eventually evolves to contempt or hate to non-progressive Jews that is whitewashed with academic discourse.



#### **4) Antisemite Complicity of Intrasemitism**

Antisemitic complicity is documented way back to the second temple era, when King Agripas II complied with the Roman empire antisemitism and their "divide and conquer" policy. Agripas II represented the Jewish elites and was killing non elite Jews during the big revolt. This influence peddling gave him a control of taxations and territories in the empire and the power of appointing Priesthood positions even in the non-elitist Jewish communities.

Antisemite complicity is found today in Think Tanks and newspapers made up of Israeli former generals and sponsored scholars that comply with state department officials that promote the dual state solution. That solution may be a plot of the annihilation of a Jewish state in stages, because Israel would have no defensible borders bordering with state or authority that promotes the killing of Jews using an education system (Under UNRWA auspice), funding terrorists, and indoctrinating in schools, media and universities the righteousness of these pogroms by using Islam fundamentalism, Arab nationalism and United Nations antisemite discourse.

In this case both intrasemists and antisemites in Europe and the United States fund or carry out the judicial and media hit jobs that demonize Orthodox or Jews that live in Judea a step the promotes a dual state solution. These think tanks may include INSS, The New Israel fund, the Reformist organizations, Betzelem, the editorials of Haaretz, YNET, Walla, Channel 11,12 and 13, Galatz, the Israel Radio authority or The Israel Institute for Democracy.

Antisemite complicity was carried out by Judenrat and Sonderkommando members that were helping the Third Reich in enslaving, seizing Jews property, killing and rounding up their Jew brothers in Ghettos and concentration camps. The Kastner affair might show a complicity by choice of socialist Jews that colluded with the Third Reich by choice for financial and socialist ideology reasons.

American reformist, FDR wall street partners or other progressive movements whitewashed FDR abandonment of European Jews by "derailing Holocaust rescue plans" to the extent that even a supreme court judge denied the Holocaust and ships with Jewish refugees would be sent to crematoriums and the changing the name of the "Jewish Refugee Board" to the "War Refugee Board". FDR appointed Breckinridge Long, who is reported to be a known antisemite, as the state department officer that would obstruct with paperwork the salvation of European jews on his behalf. In those harsh times many Jews that were complicit thought that this would be the only way of survival or saving part of the Jewry. On that part, the New York Times owned or edited by Intrasemite Jews buried or gaslighted cables and other evidences of that were reporting of the systematic execution of Jews in 1942.

"Rabbi Wise didn't take kindly to what he viewed as a rival group brashly speaking out against his friend, President Roosevelt, and capturing public attention. He became even more outraged after the Bergson group helped organize a march by 500 Orthodox rabbis from the Capitol to the White House to protest the lack of action about the extermination."

...A report stated that State Department officials (primarily Long) "not only failed to use the Government machinery at

their disposal to rescue Jews from Hitler, but have even gone so far as to use this Government machinery to prevent the rescue of these Jews." In his book "The Jews Should Keep Quiet (Franklin D. Roosevelt, Rabbi Stephen S. Wise, and the Holocaust)"

Rafael Medoff and others cite Reformist Jews adversity to orthodox Jews and compliance with the inaction of FDR and the state department in the Holocaust. These had both contempt and disregard to Orthodox and Revisionist Jews that protested against FDR complicity with the events in Europe. The secular jews under the Bergson group tried to save Jews with the help of congress and Hollywood personas were also cancel cultured by Reformist community members and coincidently were later on, the victims of the Altalena massacre. Reformist in Israel and in the United State work with progressive journalists and think tanks in Israel and actors in the State department and DNC weaponize or initiate in media hit jobs that tries to smear orthodox and Revisionist Jews, especially in election cycles.

Gerhart sent a second cable warning about the extemrination of Jewish people in Europe on August 1942 to the Reformist Jewish leader Wise who was a close political ally of FDR. This cable evidences that the government and the Reformist leadership knew of the systematic extermination of Jews not after August 1942, giving FDR and Wise enough time to act efficiently, which they didn't until pressure came from Congress. By then, it was too little and too late circa 1944.

"Three days before Yom Kippur on October 6, 1943, the first Jewish march on Washington took place with more than 400 Orthodox rabbis participating to Wise's chagrin. Organized by

the Bergson Group, this massive demonstration of very traditional rabbis in practice and appearance, who spoke Yiddish and represented a distinct old world Jewish flavor, made Wise and fully acculturated American Jews very uncomfortable, concerned of how non-Jews would react. This impressive turnout of spiritual leaders on behalf of their millions of European brethren, sought to pressure FDR's Administration to create an agency focused on rescuing the Jews from extinction. Fearing embarrassment and worse, FDR chose the meek approach of avoidance and refused to even meet with the rabbis' delegation.

"It was only under the cloud of a likely adoption of a Congressional resolution to firmly support Jewish refugees and with a pending election, did FDR agree to reverse course and establish the War Refugee Board on January 23, 1944. Treasury Secretary Henry Morgenthau Jr., the only Jew to ever serve in a FDR cabinet, was instrumental in FDR's long-coming acquiescence in saving Jewish lives. Yet, the tragic delay amounted to a loss of more than four million Jewish lives and 440,000 Hungarian Jews. Medoff emphasizes that since the WRB managed to save 200,000 Jews and 20,000 non-Jews till the war's end in May 1945—numbers that pale in comparison to the vast losses—is proof that had the WRB been established earlier it would have made a significant difference. FDR's Administration's mantra with Wise buying into it, that Jewish rescue should await Nazism's defeat, proved to be false and disastrous."

Today some progressive Israelis, by choice and not necessity,

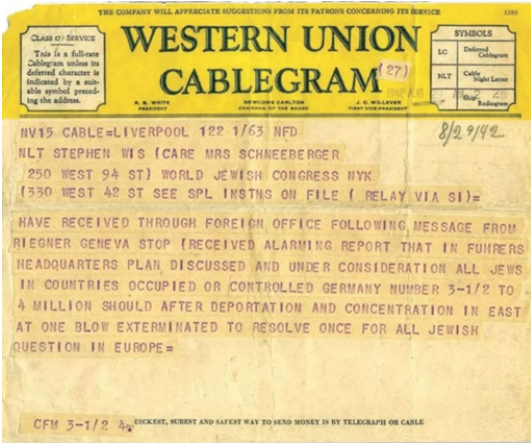
forfeit the blood of their brothers when they join or initiate a demonization campaign against Jews that live in Judea. ## 5) Orthodoxophobic Intrasemitism

The most contiguous tribalism over the ages was the ODS tribalism which refers to the anti orthodox-jew derangement syndrome. This kind of tribalism is expressed by secular Jews from the 1920's and the Catholic church in the inquisition era. The secular Jews hate or the contempt of orthodox Jews is denominated Intrasemitism. Appearance and ritual shock may occur with the first encounters of secular people with orthodox people either in public or on TV or just a word of mouth. Basically is a derivation of Xenophobia. This shock can be fomented in children books like the Poisoned Mushroom, by a news flash in the Israeli TV or an discomforting encounter in public places.

Usually this kind of perception is associated with Orthodoxophobia and is exist in Antisemitism and Intrasemitism alike. The human condition creates a need to discharge hate feelings when meeting different humans who don't share the same values, garments or race.

In turn of events secular Jews are hated in the same manner by non Jews because of the hate by association syndrome as was shown in the IVY league "From the river to the sea" protests, pogroms and the holocaust.

Justifications for disseminating or educating for Orthodoxophobia are and have elements found in is the exploiting races narratives used in the protocol of the elder of Zion, Das Kapital, Mein Kampf, Martin Luther publications and any publications that portray the Orthodox Jews as a "Society leacher" or national risk.

The most common justification in the church dominance age was the "Judas" narrative. This narrative demonizes traditional Jews by alleging that all Jews are supposedly culprits in the capture of Jesus by Romans. It evolved later on to the economy sucking narrative that demonizes Jews for their activity in the lending business by demeaning this kind of business as errant and non-suitable for Christianity or Islam. They forget to mention that the church and government limited the freedom of Jewish activity on other kinds of livelihood. Hence this CCT vilifies the victims instead of the oppressors. In the new age the justification of antisemitism is the financial and lenders class that socialism, progress and the protocol of tries to demonization.

Orthodoxophobia in Israel is propagated with smear campaign especially in the Friday night news cycle when orthodox Jews have no access to TV, it stated with media hit jobs that portray a "staged ugly angle" of manifestations of orthodox Jews against driving cars in orthodox neighbourhoods during the Sabbath. It evolved to media hit jobs and entrapments of Jews living in Judea and Samaria after being murdered or attacked. It continues in budgeting orthodox education and the entrapment of Sephardi orthodox members (Shas) by the justice system.

Progressive Jews live in an echo chamber that convinces its members that traditional Judaism is antiquated or barbaric and that assimilation is a process of modernization that has merits like Moral high ground needed an utopia, progress or social justice. This kind of realization is compatible with the perception that humanity was created by humans and not by a



divine force. If humanity is an evolutionary condition that is has non divine foundations, people who live by the Jewish orthodox tradition supposedly are a lower breed of humans or ignorant that obstruct evolution, modernization and the achievement of utopia.

Most moral high ground intrasemitism opt in, occurs after an indoctrination process made by media, academy, education or clergy. In many cases Kibbutz members are indoctrinated from young age into believing that revisionist jews and orthodox jews are allegedly bad people and Kibbutz members have higher moral standards because of their progressive Utopian values which makes them contributors and not leachers of the community for their work productivity and militarism. Today the narrative changed to the Judeaphobic narrative, that depict orthodox jews are colonialist trespassers that supposedly exploit Muslim lands. They forget that that by that rhetoric they should be removed from the middle east and that jews have been in the land before the Muslim religion was created. The biggest movement of enlightenment intrasemitism was generated by the opt- in of jews into the various flavors socialism. Although Carl Marx demonized jews as capitalists and bourgeois that exploit the working class, many jews joined that movement in act of redemption and enlightenment and rebellion against traditional values. Some o them were hoping t he assimilation through socialism opt- in would save them from pogroms and antisemitism.

## **Chastity Infringement**

Orthodox Jews and some observant Muslims uphold religious values and observe chastity rules that don't allow them to look or enjoy the looks of a women, specially when those women don't observe puritan dress code such as having an uncovered hair or exposing or accentuating wardrobe in public or on TV or media.

In some Muslim communities an uncovered face or uncovered hair may be considered a deliberate act of anti religious obscenity. Burkas and hijabs serve as means of protecting Muslim men from such a religious offense in a similar way as head cover is observed by Jewish orthodox women as well as the use of skirts instead of pants and the use of wardrobe that don't expose the arms.

Chastity Infringement may be considered Anti puritan terrorism since it may force Jews or Muslims to ghetto themselves and denies them livelihood opportunities in government and the free market. In some places this phenomena incites violence from orthodoxophobs, creates judicial or media hit jobs against orthodox targets as was the case with Arie Deryi and the kidnapping of infants from Jewish Yemenite immigrants.

Similarly, the deliberate intermingling of women in synagogues and praying places done by reform Jews and entities like Tel Aviv municipality may be considered Chastity Infringement or Anti-puritan terrorism. LGBTQAI+ parades next to orthodox or Muslim neighborhoods may also be considered Chastity Infringement since accentuating body parts and

promoting Sodom-ism shocks and offends those religious communities. The deliberate intermingling of women either sent by inciters or self promoted may as well be considered anti-puritan terrorism and an offense on the freedom of religion by publicly offending and disregarding religious values or using these values as persecution and incitements tools. To better understand this kind of offense, one can imagine the recent filming of a sodomize action in the Senate or the shock taken by parishioners when semi-naked women enters into a church or mosque or the event of a deliberate act of intercourse of Roman soldiers on holy places after destroying the temple. Anti-puritan terrorism can be enabled and promoted by government regulation and academies while using a pretext of progressive, anti-Jewish, feminist, "Diversity Inclusion and Equity" or pro LGBTQAI+ rhetoric.

In Israel Anti-puritan Terrorism is carried out through actions and policies that shock or harm the feeling of orthodox Jews within the Army, judicial system, media, public places, advertising or within government bureaucracy. The reasons for being complicit or orchestrating this kind of terrorism may include crowd assimilation policy, smearing campaign and denial of advancement or job opportunities in governments, academy and military.

Most Secular Jews in Israel don't know that they are used by the military, the justice system and media as peons that carry out anti-puritan terrorism. This kind of terrorism force some orthodox communities in Jerusalem to associate themselves with the Iranian or other Muslim theocracies that consider themselves as victims of western terrorists that try to proliferate progressive, socialist, LGBTQAI+ and anti-religious

values.

Noa Haliwa a parachuting instructor, the daughter of the Army intelligence head, and her mother used her position and her father position as in 2018 to create a smear campaign against orthodox soldiers using Antipuritan cancel culture. This smear campaign was enhanced by YNET and the head of the IDF human resources division who cancel culture orthodox soldiers for their puritan values. The army deliberately appoints women with non puritan dress code as instructors of orthodox Jews. This is done because of a double standard diversion inclusion policies that abuse orthodox values. This is the reason many orthodox jews can't or don't want to join the army.

If Haliva wouldn't be a part of the Antipuritan movement and have a former wife involved in the media leadership, probably he wouldn't be promoted and protected for his responsibility of October 7th massacre. Haliwa introduced Environment Social Government and LGBTQA+ which is a form of Antipuritan cancel culture to the intelligence community. These mindset and progressist ideology probably are the reasons that the army and media are protecting him while gaslighting other responsibilities. Haliwa was in charge of the false conceptions of Hamas economic appeasement and in charge of evaluating and assessing the intelligence needed to prevent the October massacre, and on real time he didn't abort his vacations in Eilat when alerted the night before.

Some secular commanders purposely and improperly command orthodox soldiers to not observe the Sabbath and other rituals. It is impossible to have 100% Kosher food in a place where secular or othodoxophobs are allowed to work in the kitchen for diversity inclusion policies as was demonstrated

in the porcupine IDF kitchen affair. The IDF cannot maintain a true Kosher cuisine 24/7 as long as diversity inclusion policies are maintained and as long as the human resources heads are orthodoxophobs or DEI agents.

Antipuritan policies are carried out by governments, incited mob and municipalities. Women with non puritan dresscode enter and sing on purpose in public transportation in orthodox neighbourhoods and on orthodox festivities like Yom Kipur and Simhat Tora. These actions are endorsed by the Reformist movement and other orthodox media and bureaucrats actors. Antipuritan actions were made by Merav Michaeli as a woke transportation minister that promoted public transportation in Sabbath and by people who drive on purpose during Yom Kippur and Sabbath within orthodox communities' neighborhoods.

"The court has limited the freedom of the ultra-Orthodox "within their own spaces"

Professor Eugene Lontorovich
